

# Child Custody/Conservatorship Research Guide

## Overview

This research guide includes information and resources on child custody, also known as conservatorship, in Texas. Custody is often confused with guardianship, which can also be a separate process initiated through the probate courts. When dealing with a Texas child custody case, Texas judges are legally bound by the guidance of the best interests of the child standard – this means that the judge must strive to make a custody determination best serving the child’s mental, physical, and emotional needs.
