Provide verification of school attendance with each monthly report, if applicable. Examples of accepted verification of school are: - Copy of current grades - Copy of current class schedule with grades - Copy of official or unofficial transcript
If you are required to submit a U/A with your monthly report, it must be completed within five (5) days of your report date at the Tarrant County Community Supervision and Corrections Department (CSCD) performed by CSCD (first come, first served) Central 200 W Belknap St, (basement) MALES only 7:30 am – 5:00 pm Central 300 W Belknap St, (4 th floor) FEMALES only 8:00 am – 5:00 pm 3210 Miller Ave (Miller Complex) MALE & FEMALE 7:00 am – 6:00 pm Participants given 2 chances within 30 minutes to provide a sample, if no sample is given after 2 attempts it is referred to DPP as a Stall Violation
