

CONVICTION INTEGRITY UNIT REVIEW REQUEST

INSTRUCTIONS

Please fill out the following form as best as you can. Answer the questions as completely as possible. If you wish to provide supporting documentation, <u>do not send originals or the only copy in your possession</u> <u>because any documents you submit WILL NOT BE RETURNED upon completion of the review</u>. Due to the nature of the review process and the volume of requests, the Conviction Integrity Unit (CIU) is unable to provide a specific timeframe for the progression or the completion of a review. Once the review is complete, the CIU will inform the convicted person of its conclusions.

EILIGIBILITY CRITERIA

CIU will accept review requests that meet the following criteria:

- The felony or misdemeanor conviction must arise from a Tarrant County criminal court.
- Conviction must be final without any pending investigation or prosecution regarding or related to
 the charged offense or criminal episode out of which the offense arose, including any investigation
 or prosecution of a co-defendant.
- There cannot be any pending post-conviction matters, including post-conviction writs of habeas corpus or post-conviction motions for forensic DNA testing.
- Claims must assert actual innocence or a systemic violation of due process resulting in wrongful conviction.
- Actual innocence means that the convicted person did not commit the crime or participate in any way. Claims of self-defense, consent, or lack of intent are declined.
- Claims must be based on new information or evidence that has not been presented and argued previously before the trial court or in post-conviction remedies.
- Claims must be capable of being investigated and resolved so that, if substantiated, the claims would bear directly on the issue of the convicted person's innocence.
- The records and/or evidence necessary for the re-investigation must be available to review.
- CIU does not review freestanding claims alleging ineffective assistance of counsel or errors in trial procedure, including indictment, jury selection or sentencing; questions of law; mere assertions or speculation of wrongdoing; or requests for time cuts or sentence reductions.
- CIU will review claims regardless of whether a defendant pled guilty, not guilty or no contest.

YOU MAY WISH TO SEEK LEGAL COUNSEL

Be advised that CIU does not represent the convicted person. We are unable to give legal advice, and the attorney-client privilege does not apply to our communications. If the convicted person is on probation and a revocation motion or petition is filed, any CIU review will cease and any provided information might also be disclosed to the State and the defense counsel involved in the revocation proceedings.
