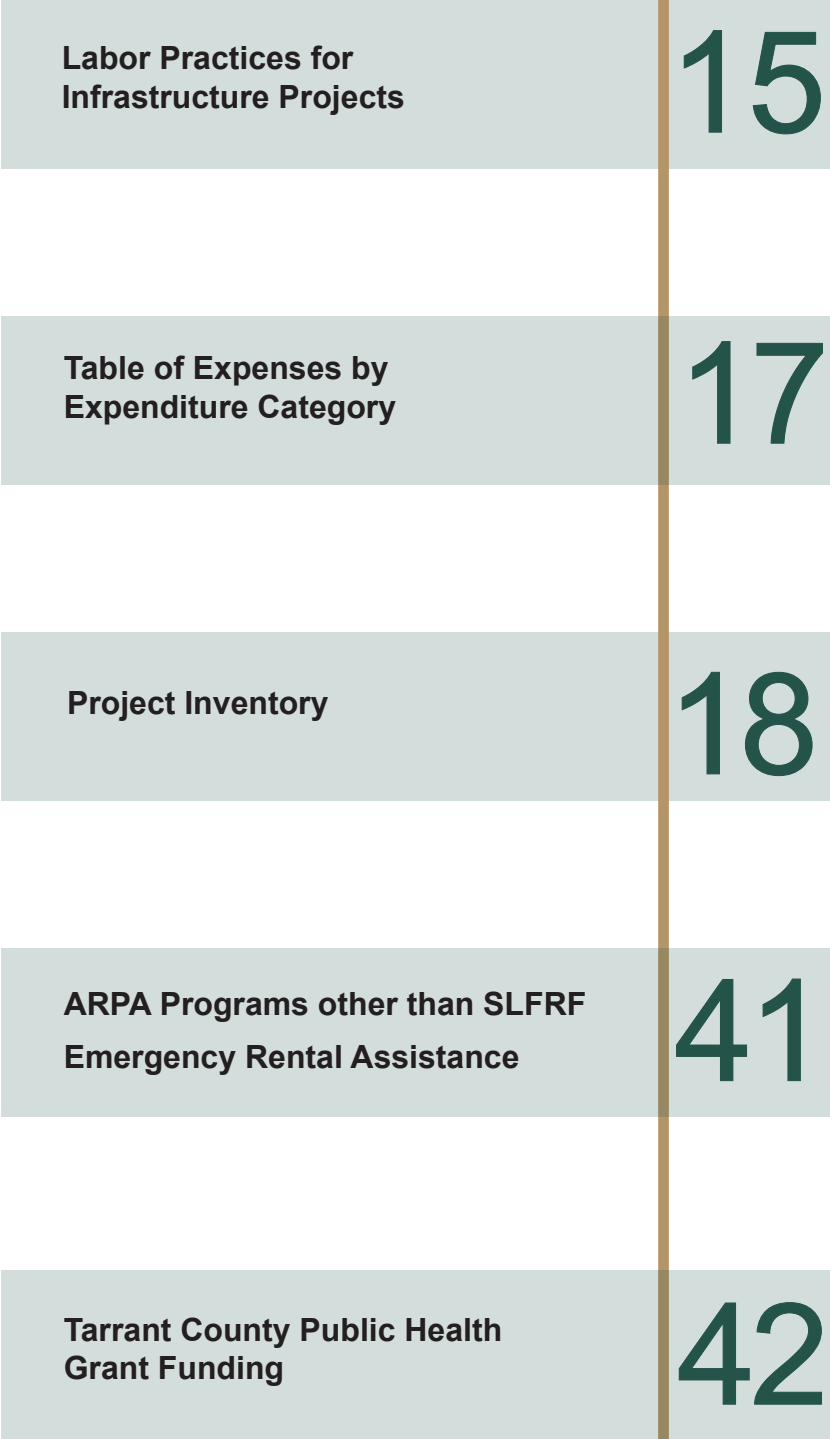

Greetings,

Since the submission of our first Recovery Plan Performance Report in August 2021, Tarrant County has made significant progress in responding to the COVID-19 pandemic and its negative socioeconomic impacts with State and Local Fiscal Recovery Funds made available through the American Rescue Plan Act. The Commissioners Court has approved nearly fifty projects which will have both an immediate and lasting impact in Tarrant County. These projects have resulted in collaborative partnerships with community stakeholders to address pressing needs.

To guide the distribution of these funds into our community, Tarrant County engaged a consultant, Innovative Emergency Management (IEM), to conduct a COVID-19 Needs and Resources Assessment. IEM delivered the Final Report at the February 8, 2022 meeting of the Tarrant County Commissioners Court. The findings of the Final Report provided significant insight into the impacts of COVID-19 on our community, and will help inform the Call for Projects which will address specific community needs through partnerships with community-based organizations.

Within this report, you will find information related to our guiding framework, community engagement efforts, evaluation practices, and projects. We are excited to share information with you about transformative partnerships, such as Alliance for Children to address abuse and alleged abuse of children and the Tarrant County Community College Foundation to support education advancement.

Please make sure to sign up for the County Judge's and your County Commissioner's newsletter to stay up to date on opportunities to provide input on ARPA funding decisions, and never hesitate to contact our office with any questions or concerns.

Commissioners Court Work Sessions

County staff facilitated a series of public work sessions during regular meetings of the Commissioners Court. These work sessions provided relevant information related to eligible uses of SLFRF funding and information from subject matter experts and key community stakeholders. In Work Session 3, for instance, subject matter experts from local mental health organizations and health providers presented an overview of pandemic-related impacts on various community health needs and associated strategies to respond to those impacts. For example, Dr. Jasmine Tiro, from UT Southwestern Medical Center, presented various community engagement strategies directed towards eliminating health disparities within Tarrant County. Additionally, Virginia Hoft, Executive Director of Mental Health Connection, presented community-focused strategies to address mental health needs exacerbated by the COVID-19 pandemic. These presentations have assisted in identifying pandemic-related community needs and helped in the development of programmatic strategies that can be supported with SLFRF funding.

COVID-19 Needs and Resources Assessment

Tarrant County Commissioners Court approved a contract with the management consulting firm Innovative Emergency Management (IEM) on Tuesday, August 3, 2021 to conduct a COVID-19 Needs and Resources Assessment within Tarrant County. The COVID-19 Needs and Resources Assessment has played a pivotal role in informing the allocation of relief funds and will ensure that SLFRF funding is deployed in a manner which efficiently, effectively, and equitably meets the needs of residents in Tarrant County.

Illustrating this point, the needs assessment is supported by GIS analysis to gauge Tarrant County's Social Vulnerability Index; a pre-March 2020 profile of the county to gauge the impact of COVID-19; input and feedback from a wide variety of community stakeholders and the public through surveys; and other vital data to inform the Commissioners Court approach.

Community engagement is the foremost priority of the COVID-19 Needs Assessment, conducted by IEM. IEM employed several strategies to engage diverse groups, community leaders, and stakeholders. Strategies that employed during the Needs and Resources Assessment include sector-specific surveys, zoom workshops with local leaders, and virtual roundtables with community stakeholders. Additionally, IEM conducted a resident survey to gauge the local impact of COVID-19.





Needs Assessment Deliverables to Guide Decision Making

IEM delivered an Interim Report to the Commissioners Court in September 2021. The Interim Report provided findings of the GIS analysis, a preliminary needs and resources assessment, and identification of immediate needs within the community. At the February 8, 2022 regular meeting of the Commissioners Court, IEM presented the Final Report and Final Strategy and Recommendations. The Final Report included results from data analyses and the needs assessment; outlined the public outreach approach employed and findings; and provided data for compliance and reporting purposes. The Final Strategy and Recommendations consists of programmatic recommendations which align with identified community needs and statutory eligible uses. These reports will help inform the Call for Projects issued by the County.

Ongoing Communication with Intergovernmental Partners

In addition to the Commissioners Court Work Sessions and COVID-19 Needs and Resources Assessment, the county conducts regular calls to engage intergovernmental partners, local nonprofits, and private sector businesses to generate and sustain cooperation, coordination, and collaborator partnering. These calls serve as a channel for information related to the pandemic and its effects on those within our communities. Among the calls are Tarrant County Judge Glen Whitley's weekly COVID-19 update for our local legislative delegation and County Administrator G.K. Maenius' ARPA discussion with local city managers to coordinate and avoid duplication of efforts in the context of local projects funded by State and Local Fiscal Recovery Funds.

Promoting Equitable Outcomes

Promoting equitable outcomes is a priority of the Tarrant County Commissioners Court and County staff, and all programs approved by the Commissioners Court are designed with equity as a primary concern. As required by the U.S. Treasury, the County has incorporated equity into the long-term sustainability goals and Focus Area outcomes.

For the first reporting period, the Commissioners Court approved the creation of Grants Manager and Program Evaluator Specialist positions, both of which are focused on compliance with federal and county policies, including the required equitable use guidelines. Collaborating with IEM, Tarrant County conducted a county-wide Needs and Resources Assessment intended to identify how best to allocate limited SLFRF funding into communities and neighborhoods with the greatest need.

The Needs and Resources Assessment was facilitated with stakeholder engagements including key community members and leaders to guarantee strategic COVID-19 pandemic recovery is inclusive to the needs of historically underrepresented groups. Vulnerability factors were developed using the Department of Housing and Urban Development (HUD) qualified census tracts (QCTs), the Centers for Disease Control (CDC) Social Vulnerability Index, and the U.S. Census Bureau Community Resilience Estimates. While the U.S. Treasury Final Rule encourages the use of QCTs to promote equitable outcomes, Tarrant County also deems it important to recognize that highly vulnerable areas outside QCTs may have been disproportionately affected by the COVID-19 pandemic.

Findings from the COVID-19 Needs and Resources Assessment provided data to show that equity is central to achieving the goals set within each of the Focus Areas. For example, a deeper dive into the data from community surveys revealed that minority and women-owned businesses experienced specific challenges such as reduced operating hours and use of personal and retirement savings to maintain economic viability. Similarly, many Tarrant County residents experienced limited or no access to quality childcare and youth programs, highlighting the need for increased accessibility, especially for those within low-income communities.

Takeaways such as these helped inform Tarrant County's prioritization of SLFRF to help achieve equitable outcomes.

Promoting Equitable Outcomes



Use of Funds

Informed by public feedback, and to establish a framework for utilization of State and Local Fiscal Recovery Funds (SLFRF), the Tarrant County Commissioners Court adopted four (4) Focus Areas along with goals and funding allocations. Coupled with the findings from the countywide COVID-19 Needs and Resources Assessment, these Focus Areas guide the development, approval, and implementation of programmatic activities funded by SLFRF. The four (4) Focus Areas and their respective goals are detailed below.

Focus Area 1: Prepare for the Future

(Allocation: \$85,454,676)

Through investments in our workforce, facilities, and programs, Tarrant County will position itself to efficiently, effectively, and equitably serve the needs of our community.

Expenditure Categories

Expenditure Categories are provided by the United States Department of Treasury to streamline the reporting of the use of SLFRF funding. In the section below, you will find examples of the County's use of funds within each expenditure category for the first reporting period, covering May 10, 2021 to March 24, 2022. A complete inventory of approved projects can be found in the section titled "Project Inventory."

Expenditure Category 1: Public Health

To date, the Tarrant County Commissioners Court has authorized twenty-three (23) projects under Expenditure Category 1. Each project aims to mitigate COVID-19 in Tarrant County facilities, ensure equitable administration of COVID-19 testing and vaccinations, and/or improve behavioral health outcomes in Tarrant County .

Examples of projects in Expenditure Category 1:

- Creation and operation of a Mental Health Jail Diversion center to divert misdemeanor trespassing offenders from the County jail and provide mental and behavioral health services
- Partnership with the University of Texas Southwestern/Moncrief Cancer Institute to provide life-saving cancer screenings that were delayed or deferred due to the pandemic

Expenditure Category 2: Negative Economic Impacts

The Tarrant County Commissioners Court has thus far authorized eleven (11) projects and programs under Expenditure Category 2. The programs are geared toward providing support to businesses and nonprofits that experienced negative economic impacts as a result of the COVID-19 pandemic. The identified needs for the Tarrant County population range from food insecurity to supportive solutions for the housing insecure to small business support, including minority, veteran, and women-owned businesses.

To ensure resources are distributed with a focus on equity, a County Vulnerability Analysis was conducted to identify communities disproportionately impacted by the pandemic. The following resources were used: The U.S. Census Bureau Community Resilience Estimates (CRE), Centers for Disease Control and Prevention Social Vulnerability Index (SVI), and the U.S Department of Housing and Urban Development (HUD) Qualified Census Tracts (QCT). Each are explained below:

The U.S. Census Bureau Community Resilience Estimates

The CRE measures the capacity of individuals and households within a community to absorb, endure, and recover from the impacts of a disaster. CRE estimates are produced using information on individuals and households from the 2018 American Community Survey (ACS), the Census Bureau's Population Estimates Program, and publicly available health-condition rates from the National Health Interview Survey.

Centers for Disease Control and Prevention Social Vulnerability Index

The SVI is a composite index created to help public health officials and emergency response planners identify and map communities that will most likely need support before, during, and after a disaster. The SVI evaluates 15 variables in four themes to determine the level of social vulnerability of each census tract using 2018 ACS data. Each variable is used to calculate the theme, which is used for the overall index value.

U.S Department of Housing and Urban Development (HUD) Qualified Census Tract

HUD designates QCTs, which are census tracts that have at least 50 percent of households with incomes below 60 percent of the Area Median Gross Income (AMGI). For example, pre-COVID data confirms Tarrant County was a high-quality childcare desert prior to the pandemic. The negative effects of the pandemic on already economically fragile communities amplified the need for quality childcare throughout the county.

Examples of projects in expenditure category 2:

- Funding for Meals on Wheels facility expansion to allow for continued services to the increasing population of elderly and homebound residents
- Funding for nonprofit service providers to expand technical assistance and entrepreneurship training to women, veteran, and minority-owned businesses
- Support for families caring for individuals with disabilities
- Funding to increase the number of deeply affordable, transitional, and permanent supportive housing units in Tarrant County

Expenditure Category 3: Services to Disproportionately Impacted Communities

The Tarrant County Commissioners Court authorized programs under Expenditure Category 3 that provide funding in areas of education, childcare, and innovation geared to strengthen Tarrant County residents and businesses. The decision was guided by public stakeholder engagement in roundtables, focus groups, and survey responses facilitated by a third-party consultant, Innovative Emergency Management (IEM). To achieve a wide range of input, Tarrant County engaged multiple affected populations in conversation around focused topics. For example, Quality Childcare and Out-of-School Care Roundtables with local stakeholders provided a deeper reflection of the challenges parents, childcare providers, youth service providers, and private sector businesses experience in the wake of the pandemic. Participants recommended readying children in early learning settings to better prepare future Tarrant County generations for success. Through its Call for Proposals, Tarrant County will focus on programs and projects aimed at reducing pre-existing educational disparities that have been exacerbated by the pandemic.

Expenditure Category 4: Premium Pay

The Tarrant County Commissioners Court has not authorized any program under Expenditure Category 4 and has no current plan to expend funds under this category.

Expenditure Category 5: Water, Sewer, and Broadband Infrastructure

The Tarrant County Commissioners Court intends to authorize programs and projects under Expenditure Category 5. As the Tarrant County community increases in population and increasingly engages in remote work and online schooling options, there is a need to invest in critical infrastructure. The county is in process of exploring potential projects and expending funds under this category in conjunction with the recommendation of the COVID-19 Needs and Resources Assessment which advises the county to invest in broadband and water/sewer infrastructure.

Expenditure Category 6 – Revenue Replacement

Based on current guidance, the Tarrant County Commissioners Court is opting for the \$10M standard revenue replacement allowance. The Commissioners Court will consider projects under this Expenditure Category through internal and external stakeholder engagement.

Tarrant County Commissioners Court and staff are committed to ensuring compliance with labor standards set forth in 2 CFR 200 and the Davis-Bacon Act, as applicable. To that end, the Commissioners Court approved a Grant Manager position and a Davis-Bacon Act Compliance Manager position to develop a compliance framework for ARPA grant funding. To ensure subrecipient compliance with labor standards, the Commissioners Court and staff are engaging the consultant Innovative Emergency Management (IEM). IEM will work with subrecipients to assess labor standards and procedures, conduct site visits, and other compliance monitoring activities.

Use of Evidence

The ARPA program evaluation focuses on the long-term COVID-19 pandemic recovery and economic viability outcomes of Tarrant County residents, businesses, and nonprofits. The research questions address four Focus Area outcomes:

- Preparing Tarrant County for the Future
- Improving Public Health and Wellness
- Revitalizing the Economy
- Strengthening the Community

Tarrant County evaluates all programs and projects proposals requesting SLFRF dollars based upon their proposed program performance plan and demonstrated ability to evaluate the short and long-term applicability of the program/ project. After careful and conscientious vetting of programs and projects to ensure alignment with Tarrant County Focus Area outcomes, a program/ project reporting document is created. The primary purpose of the reporting document is to capture and meticulously evaluate how current and future SLFRF-funded programs and projects honor the guidelines outlined in the Interim and subsequent Final Rule.

The performance measures for all subrecipients are geared toward illustrating the relationship between the County's intended equitable outcomes and actual organizational-level results. While each subrecipient has a unique set of key performance indicators, we highlight the collection of demographic data to more readily identify equity dimensions necessary to achieve Focus Area outcomes. Future reports will illustrate how all Tarrant County residents were treated with dignity, respect, and value in their access to and participation in the COVID-19 recovery.

Labor Practices for Infrastructure Projects

The data collected in the reporting document sets the evaluation framework at the granular organizational level and the broader county-level. As such, evaluation of each program and project is comprised of the following activities:

- **Engaging Stakeholders to Build Rapport and Familiarity with the Agency / Department Overall COVID-19 Impact and Equitable Recovery Agenda**
- **Developing a complete Understanding of the Program / Project**
- **Gathering Credible Evidence of What Service is provided, Who is Served, and the Outcomes of the Service**
- **Justifying Conclusive findings with Published Scholarly and Practitioner-based Research**
- **Outlining Lessons Learned to Inform Future Reporting and Allocation of Funding**

In essence, each approved program and project involves continuous stakeholder participation whereby the Program Evaluation team works closely with SLFRF subrecipients to gather rich qualitative data and guide quantitative inquiry. During the pre-evaluation discussions with subrecipients the evaluation's purpose is presented, and insight garnered to clarify how the funded activities intend to bring about the expected outcomes and community benefit.

Next, questions are developed to establish boundaries for the evaluation and guide performance measure selection. The next phase will subsume a strategic assessment into the programmatic performances with the goal of gathering insight about the observation-based measures of the first quarter quality of sub-recipient and Tarrant County interactions. As such, the program evaluation team will conduct site visits and administer surveys to better inform Quarter 1 reporting. We believe this step is necessary to identify manners in which to improve the project/ program competition process, and other factors that may contribute to the project/ program meeting the appropriate Focus Area goal.

The next report to Treasury will describe in detail the research questions and the evaluation design. The questions will support the systematic collection and guide measurement of programmatic data highlighting whether the specified target outcomes were met. The evaluation will use this data to interpret the manner in which Tarrant County utilized funds for each program/ project to achieve each Commissioner's Court-approved Focus Area outcome. Building evidence of this kind will not only inform the agencies, the public, and the county, but also the field of public administration where there is constant innovation and evidence-sharing regarding the provision of redistributive social services.

Emergency Rental Assistance Program (ERAP)

The Tarrant County Emergency Rental Assistance Program (ERAP) is designed to assist eligible households who are unable to pay rent and/or utilities due to the COVID-19 pandemic as established by section 501 of Division N of the Consolidated Appropriations Act, 2021 (ERA 1) and Section 3201 of Subtitle B, Title III of the American Rescue Plan Act, 2021 (ERA 2). Tarrant County received \$24,281,300 from the CAA and \$26,407,662 from ARPA to assist with emergency rental assistance needs.

Assistance may be provided for unpaid, overdue rent (arrears) from April 1, 2020, and for future rent. Using a combination of ERA 1 and ERA 2, total months of assistance is not to exceed 15 months, or 18 months, if necessary, for housing stability as defined by US Treasury.
