Greetings,

*Tarrant County has made meaningful progress since submission of our April 2022 Recovery Plan Performance Report update. In April, the Commissioners Court authorized a Community Programs Call for Proposals to address pandemic-related needs that exist within our community. The call garnered 131 unique proposals from 95 nonprofit, governmental, and quasi-governmental agencies for a total of \$208.5 million in requested funding. Of those proposals, 35 have been approved for a total of \$35.5 million of State and Local Fiscal Recovery Funds, leveraging an additional \$26 million in matching funds from private donations and other contributions.*

*During the months of May and June, County staff worked with community stakeholders and subject matter experts to finalize a proposal for a \$32.5 million program for deeply affordable and permanent supportive housing. The County hopes to leverage these dollars in public-private partnerships to add at least 250 units to the Tarrant County housing inventory.*

*On July 11, the \$25 million Tarrant County Small Business Workforce Recovery Grant opened to applicants and, as of the date of this letter, has received nearly 2,000 applications, 65 percent of which are from minority- and women-owned small businesses.*

*Lastly, the County has made major strides toward a \$45 million strategic investment into quality child care programs and increased infant and toddler infrastructure in areas with the highest level of need.*

*This Performance Report outlines these new accomplishments and provides a detailed overview of the County's efforts to lead the community through an equitable and robust recovery from the COVID-19 pandemic. Our achievements thus far are possible thanks to strong community partnerships and a dedicated group of high-quality leaders, employees and consultants who have committed themselves to ensuring the overall success of Tarrant County's ARPA program.*

# General Overview

## Community Engagement

To ensure public participation and transparency are at the core of Tarrant County's American Rescue Plan Act (ARPA) State and Local Fiscal Recovery Funds (SLFRF) program, the Commissioners Court facilitated numerous opportunities for community engagement and has prioritized the accessibility of program information to the public. Through work sessions highlighting community needs to a countywide needs assessment and multiple countywide public surveys, over 5,000 businesses, nonprofits and individuals participated in the ARPA FRF process. All programs considered for ARPA funding are discussed and voted on during the Commissioners Court meetings. In addition, the County provides bi-monthly updates on all ARPA grant funds and all programs funded with SLFRF to the public via the County website.

## Commissioners Court Work Sessions

County staff facilitated a series of public work sessions during regular meetings of the Commissioners Court. The work sessions provided relevant information related to eligible uses of SLFRF funding and provided information from local subject matter experts and key community stakeholders on pressing community needs in the wake of the COVID-19 pandemic. In Work Session 3, for instance, subject matter experts from local healthcare organizations presented an overview of pandemic-related impacts on various community health needs and suggested strategies to respond to those impacts.

For example, Dr. Jasmine Tiro, from UT Southwestern Medical Center, presented various community engagement strategies directed towards eliminating health disparities within Tarrant County. Additionally, Virginia Hoft, Executive Director of Mental Health Connection, presented community-focused strategies to address mental health needs exacerbated by the COVID-19 pandemic. These presentations assisted in identifying pandemic-related community needs and informed the development of programmatic strategies eligible to be supported with SLFRF funding.

## COVID-19 Needs and Resources Assessment

Tarrant County Commissioners Court approved a contract with the management consulting firm Innovative Emergency Management (IEM) to conduct a COVID-19 Needs and Resources Assessment across Tarrant County. The COVID-19 Needs and Resources Assessment has played a pivotal role in informing the allocation of relief funds and ensuring that SLFRF funding is deployed in a manner which efficiently, effectively, and equitably meets the needs of residents in Tarrant County.

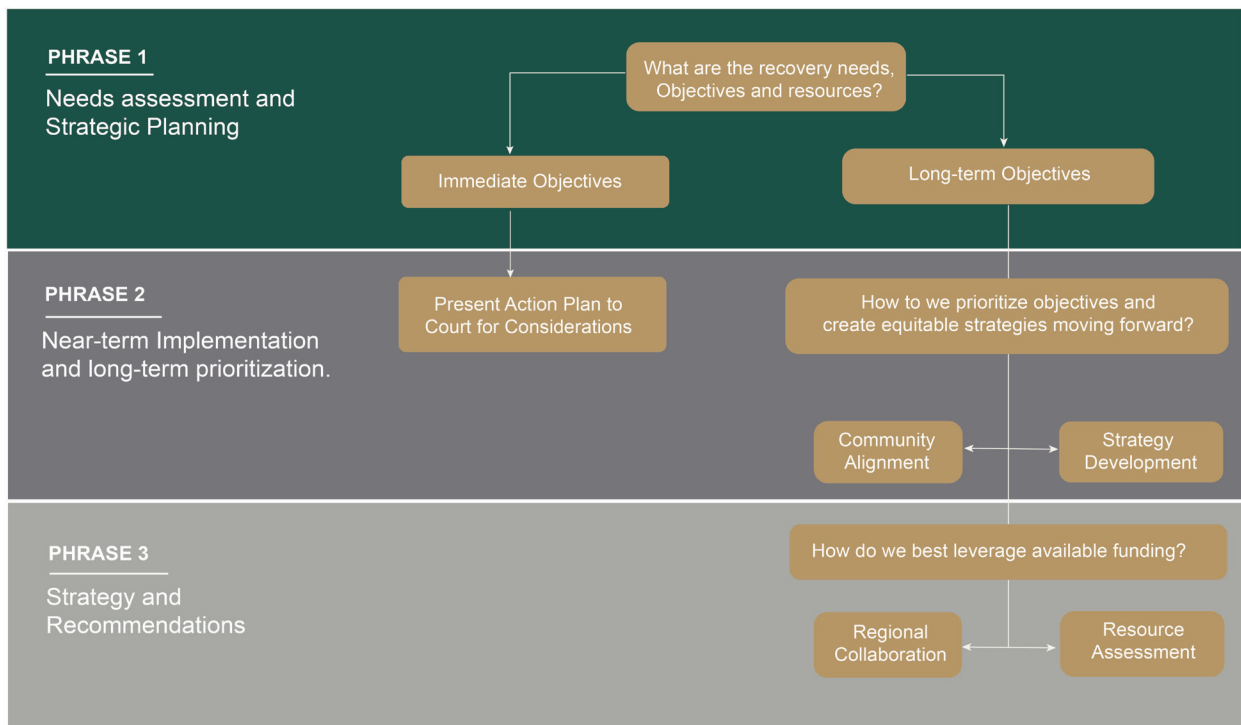
Illustrating this point, the needs assessment is supported by GIS analysis to gauge Tarrant County's Social Vulnerability Index; a pre-March 2020 profile of the County to gauge the impact of COVID-19; input and feedback from a wide variety of community stakeholders and the public through surveys; and other vital data to inform the Commissioners Court approach.

Community engagement is the foremost priority of the COVID-19 Needs Assessment conducted by IEM. IEM employed several strategies to engage diverse groups, community leaders, and stakeholders. Strategies employed during the Needs and Resources Assessment include sector-specific surveys, workshops with local leaders, and virtual roundtables with community stakeholders. Additionally, IEM conducted a resident survey to gauge the local impact of COVID-19.

## Needs Assessment Deliverables to Guide Decision Making

IEM delivered an Interim Report to the Commissioners Court in September 2021. The Interim Report provided findings of the GIS analysis, a preliminary needs and resources assessment, and identification of immediate needs within the community. At the February 8, 2022 regular meeting of the Commissioners Court, IEM presented the Final Report and Final Strategy and Recommendations.

The Final Report included results from data analyses and the needs assessment; outlined the public outreach approach employed and findings; and provided data for compliance and reporting purposes. The Final Strategy and Recommendations contain programmatic recommendations which align with identified community needs and statutory eligible uses of SLFRF. These reports have assisted the County in the development of various programs and calls for projects to address identified areas of need.



## Ongoing Communication with Intergovernmental Partners

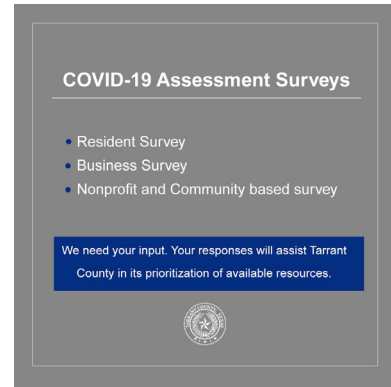
In addition to the Commissioners Court Work Sessions and COVID-19 Needs and Resources Assessment, the County conducts regular calls to engage intergovernmental partners, local nonprofits and private sector businesses to generate and sustain cooperation, coordination, and collaborative partnerships. The calls serve as a channel for information related to the pandemic and its effects on those within our communities. Among the calls are Tarrant County Judge Glen Whitley’s weekly COVID-19 update for our local legislative delegation and County Administrator G.K. Maenius’ ARPA discussion with local city managers to coordinate and avoid duplication of efforts in the context of local projects funded by State and Local Fiscal Recovery Funds.

# General Overview

## Social Media

The County has used social media to communicate information about SLFRF funded programs and opportunities for assistance. By using a variety of platforms, the County has been able to successfully communicate essential program information to a wide audience. Social media allows the County to reach residents quickly and receive feedback in real time. This public engagement tactic helps ensure programs and aid are reaching those who are most in need.

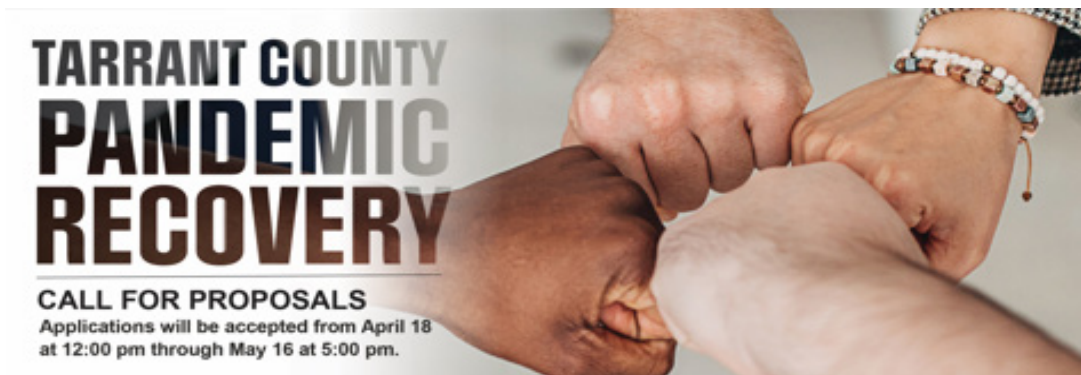

## Call for Proposals

The Commissioners Court allocated \$35.5 million for a community based call for proposals with nonprofit, government, and quasi-governmental partners. Proposals were accepted for programs that addressed community needs and mitigate the impacts of the COVID-19 pandemic.

The County utilized a multi-faceted outreach approach to solicit a widespread response to the call. The County received 131 proposals totaling over \$208 million in requests. This response demonstrates the ongoing need in the Tarrant County community to overcome the effects of the pandemic.





Tarrant County understands the important role that equity plays in the allocation, distribution, and implementation of SLFRF funded programs. Through its program, the County has intentionally focused on goals and outcomes that ensure all County residents will benefit from the investment of these historic federal dollars. Additionally, as directed by Executive Order #13985, “Advancing Racial Equity and Support for Underserved Communities Through the Federal Government,” Tarrant County has designed its SLFRF program framework to increase investments in underserved communities and provide funding for projects that prioritize equitable outcomes.

### Equity Approach

Tarrant County has taken a collaborative approach to advance and promote racial and economic equity within the allocation of SLFRF funds. Central to the program are goals that address disparate outcomes in physical, behavioral, and mental health; economic vulnerability; housing instability; and youth and senior supports. Through dedicated program staff, the County will continue to assess progress towards these goals.

In Year 1, the Tarrant County Commissioners Court adopted the following policy statement:

**“ It is the policy of the Tarrant County Commissioners Court to promote the highest and best use of funds received through the American Rescue Plan Act by leveraging existing resources and prioritizing programs without an alternate source of funding. The Commissioners Court will direct the use of these funds in four focus areas: Prepare for the Future, Improve Public Health and Wellness, Revitalize the Economy, and Strengthen the Community ”**  
(Tarrant County Commissioners Court 2021).

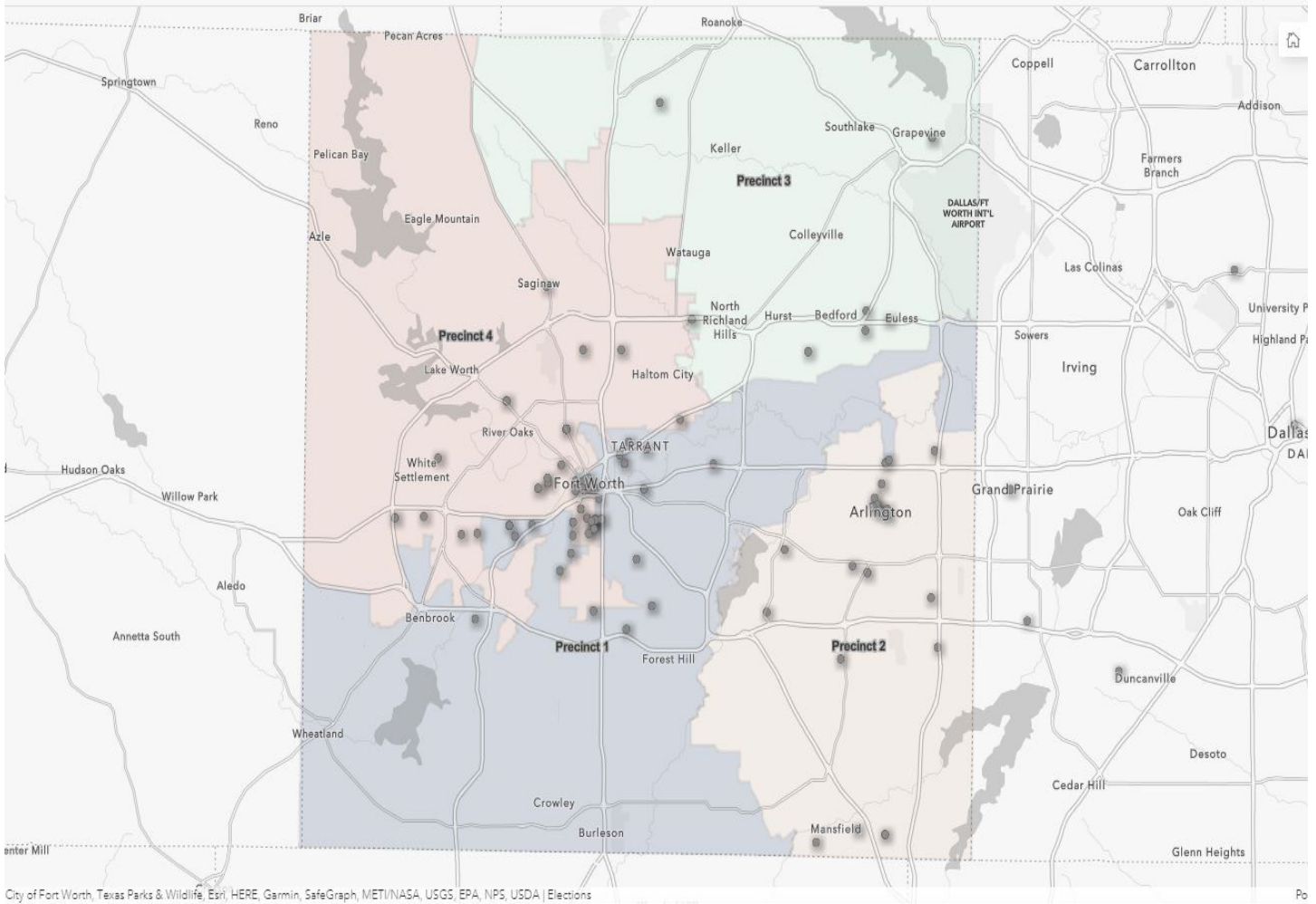
Within each Focus Area, outcome and performance goals have been developed, collaboratively assessed, and are now being tested as evaluation measures with equity in mind. In essence, the Focus Area outcomes set a firm foundation for the countywide effort to address social and economic gaps for those most vulnerable to the impact of the pandemic.

Each Focus Area goal prescribes outcomes that call for equity in the context of closing gaps and promoting universal levels of service. The strategy to close gaps targets programs and services for historically underserved populations and individuals and families from varied socio-economic backgrounds.

Tarrant County uses quantitative and qualitative evaluation to further promote equity. The quantitative assessment of SLFRF projects and programs are dependent on qualitative evaluation methods to contextualize the demographic data collected, which includes race, gender, and geographic and basic socioeconomic data. Tarrant County will continue utilizing subrecipient community partners to enrich our understanding of the diverse experiences of the residents they serve. For example, demographic data collected by community health partners helps inform the County’s approach to improving disparities in public health outcomes.

# Promoting Equitable Outcomes

## Focus Area Outcomes

Each Focus Area outcome is the result of an approach that considers both the administrative needs of the program and ensures effective community impact by subrecipients. Each Focus Area contains specific goals that serve as outcomes each subrecipient should demonstrate, as applicable to their project.

The table below contains selected subrecipient programs and their respective project level and equity outcomes. The examples in this table show that equity is central to the program performance of all relevant SLFRF subrecipients. At the basic level of evaluation, the contract between Tarrant County and sub-recipients is reviewed for alignment with the Focus Area outcomes. Upon approval, program staff meet with subrecipients to establish various performance metrics and identify how equity will be achieved within each program.

## Use of Funds

Informed by public feedback, the Tarrant County Commissioners Court adopted four (4) Focus Areas along with goals and funding allocations to establish a framework for utilization of State and Local Fiscal Recovery Funds (SLFRF). Coupled with the findings from the countywide COVID-19 Needs and Resources Assessment, these Focus Areas, as illustrated below, are county-level outcomes intended to guide the development, approval and implementation of programmatic activities funded by SLFRF.



## Focus Area 1: Prepare for the Future

(Allocation: \$85,775,584)

*Through investments in our workforce, facilities and programs, Tarrant County will position itself to efficiently, effectively and equitably serve the needs of our community.*

Responding to the challenges of the COVID-19 pandemic, Tarrant County Commissioners initialized an immediate response to mitigate the spread of the disease, while protecting employees and those utilizing county services. While many mitigation measures to prevent the spread of infection created some barriers to providing government services, Tarrant County focused on the pre-crisis vulnerabilities and developed strategies to create resiliency.

*Through investments in our public health infrastructure, Tarrant County will transform its public health system to equitably address the health needs of the community and ensure pandemic preparedness.*

Through assessment and open communication with stakeholders from the community, those on the frontlines, and policymakers, Tarrant County is working to identify incremental improvements to impact large-scale public health management changes. To achieve enhanced population health and sustain quality improvement, Tarrant County is focused on equitable access to quality services and programs. By engaging partners in the assessment and strategic planning efforts of Tarrant County Public Health, the public health administration remains positioned to sustain a countywide culture of health improvement while meeting the needs of the community to mitigate the impacts of the COVID-19 pandemic.

(Allocation: \$81,507,820)

*Tarrant County will position the local economy for a strong and equitable recovery by investing in the training, development, and support of our current and future workforce; supporting disproportionately impacted industries; and identifying innovative opportunities for growth.*

To facilitate a strong economic recovery, the Commissioners Court prioritized programs that serve as a catalyst for economic and social recovery, grow and strengthen the job opportunities available, equip our emerging workforce, and ensure working families have the childcare infrastructure they need.

## Focus Area 4: Strengthen the Community

(Allocation: \$74,443,865)

*Through investments in our community, Tarrant County will ensure residents are equipped with the necessary resources to recover from the negative socioeconomic impacts of the pandemic.*

Through investment in programs and projects seeking to address homelessness, food insecurity, violence and support for aging and youth populations, the County hopes to address the increased costs and social impacts affecting the quality of life for the County's most vulnerable populations.

## Expenditure Categories

### Expenditure Category 1: Public Health

To date, the Tarrant County Commissioners Court has authorized twenty-seven (27) projects under Expenditure Category 1. Each project aims to mitigate COVID-19 in Tarrant County facilities, ensure equitable administration of COVID-19 testing and vaccinations, and/or improve behavioral health outcomes in Tarrant County.

#### Examples of projects in Expenditure Category 1:

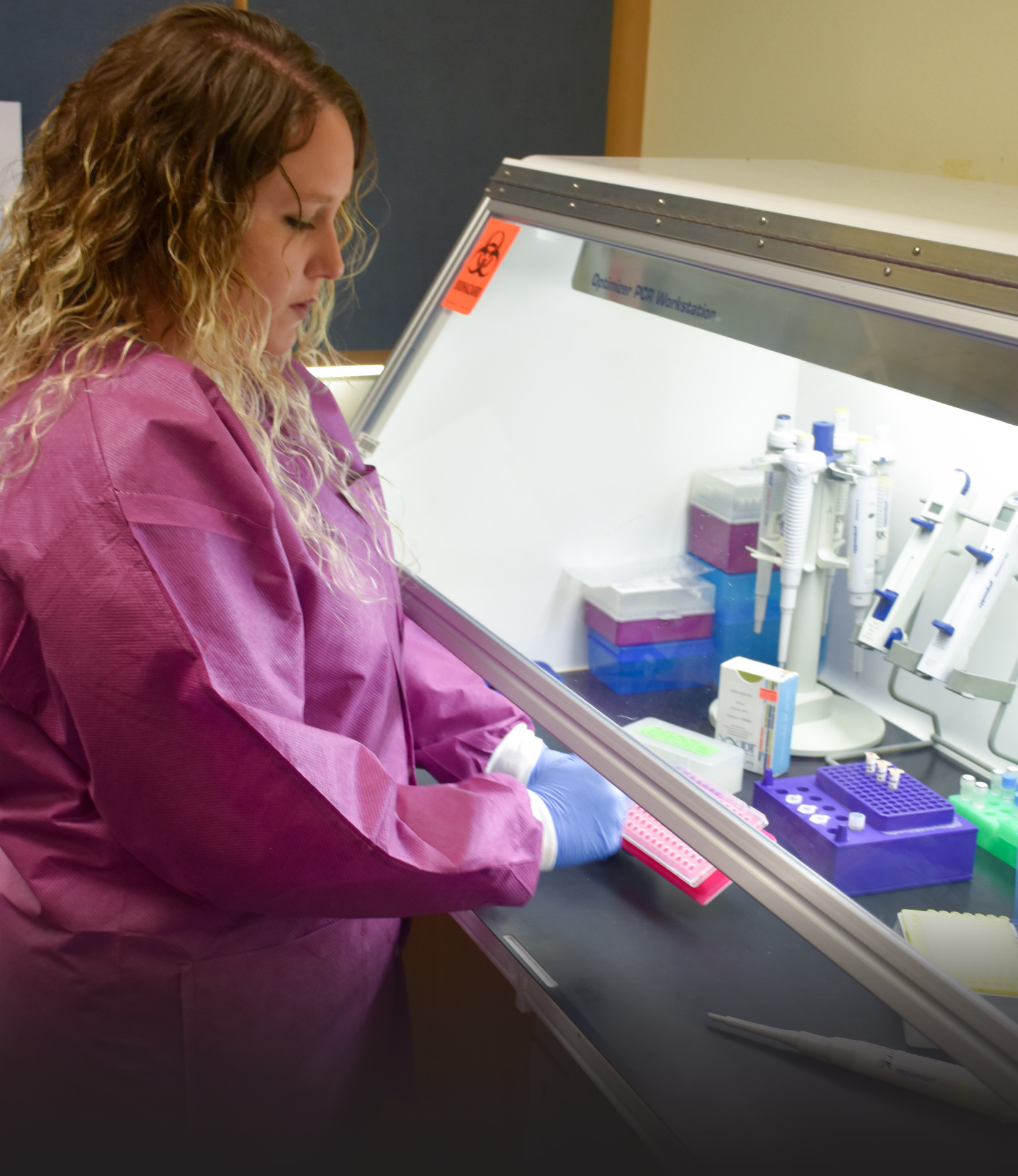
- Creation and operation of a Mental Health Jail Diversion center to divert misdemeanor trespassing offenders from the County jail and provide mental and behavioral health services
- Partnership with the University of Texas Southwestern/Moncrief Cancer Institute to provide life-saving cancer screenings that were delayed or deferred due to the pandemic

### Expenditure Category 2: Negative Economic Impacts

The Tarrant County Commissioners Court has thus far authorized sixteen (16) projects and programs under Expenditure Category 2. The programs are geared toward providing support to businesses and nonprofits that experienced negative economic impacts because of the COVID-19 pandemic. The identified needs for the Tarrant County population range from food insecurity to supportive solutions for the housing insecure to small business support, including minority, veteran, and women-owned businesses

To ensure resources are distributed with a focus on equity, a County Vulnerability Analysis was conducted to identify communities disproportionately impacted by the pandemic. The following resources were used: the U.S. Census Bureau Community Resilience Estimates (CRE), Centers for Disease Control and Prevention Social Vulnerability Index (SVI), and the U.S Department of Housing and Urban Development (HUD) Qualified Census Tracts (QCT).

### The U.S. Census Bureau Community Resilience Estimates

The CRE measures the capacity of individuals and households within a community to absorb, endure, and recover from the impacts of a disaster. CRE estimates are produced using information on individuals and households from the 2018 American Community Survey (ACS), the Census Bureau's Population Estimates Program, and publicly available health-condition rates from the National Health Interview Survey.

### Centers for Disease Control and Prevention Social Vulnerability Index

The SVI is a composite index created to help public health officials and emergency response planners identify and map communities that will most likely need support before, during, and after a disaster. The SVI evaluates 15 variables in four themes to determine the level of social vulnerability of each census tract using 2018 ACS data. Each variable is used to calculate the theme, which is used for the overall index value.

### U.S Department of Housing and Urban Development (HUD) Qualified Census Tract

HUD designates QCTs, which are census tracts that have at least 50 percent of households with incomes below 60 percent of the Area Median Gross Income (AMGI). For example, pre-COVID data confirms Tarrant County was a high-quality childcare desert prior to the pandemic. The negative effects of the pandemic on already economically fragile communities amplified the need for quality childcare throughout the county.

#### **Examples of projects in Expenditure Category 2:**

- Funding for Meals on Wheels facility expansion to allow for continued services to the increasing population of elderly and homebound residents
- Funding for nonprofit service providers to expand technical assistance and entrepreneurship training to women, veteran, and minority-owned businesses
- Support for families caring for individuals with disabilities
- Funding to increase the number of deeply affordable, transitional, and permanent supportive housing units in Tarrant County

### **Expenditure Category 3: Services to Disproportionately Impacted Communities**

The Tarrant County Commissioners Court has authorized six (6) programs under Expenditure Category 3 that provide funding in areas of education, childcare, and innovation geared to strengthen Tarrant County residents and businesses. The decision was guided by public stakeholder engagement through roundtables, focus groups, and survey responses facilitated by a third-party consultant, Innovative Emergency Management (IEM). To achieve a wide range of input, Tarrant County engaged multiple affected populations in conversation around focused topics.

For example, Quality Childcare and Out-of-School Care roundtables with local stakeholders provided a deeper reflection of the challenges parents, childcare providers, youth service providers, and private sector businesses experience in the wake of the pandemic. Participants recommended readying children in early learning settings to better prepare future Tarrant County generations for success. Through its Call for Proposals, Tarrant County will focus on programs and projects aimed at reducing pre-existing educational disparities that have been exacerbated by the pandemic.

### **Expenditure Category 4: Premium Pay**

The Tarrant County Commissioners Court has not authorized any program under Expenditure Category 4 and has no current plan to expend funds under this category.

### **Expenditure Category 5: Water, Sewer, and Broadband Infrastructure**

The Tarrant County Commissioners Court has authorized two (2) programs and projects under Expenditure Category 5. As the Tarrant County community grows in population and increasingly engages in remote work and online schooling options, there is a need to invest in critical infrastructure. The County is in process of exploring potential projects and expending funds under this category in conjunction with the recommendation of the COVID-19 Needs and Resources Assessment which advises the county to invest in broadband and water/sewer infrastructure.

### **Expenditure Category 6 – Revenue Replacement**

Based on current guidance, the Tarrant County Commissioners Court is opting for the \$10 million standard revenue replacement allowance. The Commissioners Court will consider projects under this Expenditure Category through internal and external stakeholder engagement.

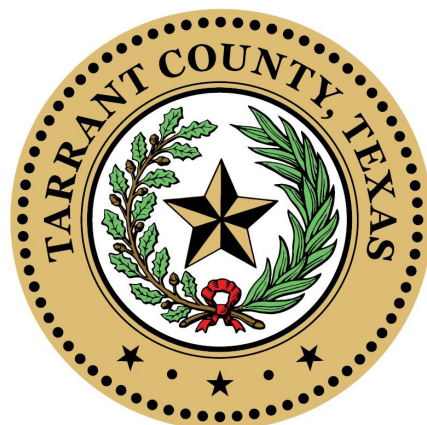
### **Expenditure Category 7 – Administrative**

The Tarrant County Commissioners Court has authorized two (2) programs under Expenditure Category 7 to address SLFRF administrative program needs.



Tarrant County Commissioners Court and staff are committed to ensuring compliance with labor standards set forth in 2 CFR 200 and the Davis-Bacon Act, as applicable. To that end, the Commissioners Court approved a Grant Manager position and a Compliance Manager position to develop a compliance framework for ARPA grant funding.

To ensure subrecipient compliance with labor standards, the Commissioners Court and staff are engaging the consultant Innovative Emergency Management (IEM). IEM will work with subrecipients to assess labor standards and procedures, conduct site visits, and engage in other compliance monitoring activities.



## Use of Evidence

*ARPA program evaluation focuses on long-term COVID-19 pandemic recovery and economic viability outcomes of Tarrant County residents, businesses, and nonprofits.*

Tarrant County evaluates all program and project proposals requesting SLFRF dollars based upon their proposed program performance plan and demonstrated ability to evaluate the short and long-term impact of the program or project. After careful vetting to ensure alignment with Tarrant County Focus Area outcomes, a reporting document is created. The primary purpose of the reporting document is to capture and evaluate how SLFRF- funded programs and projects adhere to the guidelines in the Final Rule.

The performance measures for all subrecipients illustrate the relationship between the County's intended outcomes and actual organizational-level results. While each subrecipient has a unique set of key performance indicators, we highlight the collection of demographic data to identify equity dimensions necessary to achieve Focus Area outcomes.

The data collected in the reporting document establishes the evaluation framework at the organizational and county levels. The evaluation of each program and project is comprised of the following activities:

- **Engaging stakeholders to build rapport and familiarity with the organization**
- **Establishing a COVID-19 impact and equitable recovery agenda**
- **Developing a complete understanding of the program/project**
- **Gathering credible evidence of what service is provided, who is served, and the outcomes of the service**
- **Justifying conclusive findings with published scholarly and practitioner-based research**
- **Outlining lessons learned to inform future reporting and allocation of funding**

Each approved program and project involves continuous stakeholder participation whereby dedicated program staff work closely with SLFRF subrecipients to gather qualitative data and guide quantitative inquiry. During the pre-evaluation discussions with subrecipients, the evaluation's purpose is presented and the organization explains how the funded activities are intended to bring about the expected outcomes and community benefits.

Next, questions are developed to establish boundaries for the evaluation and guide performance measure selection. The next phase will incorporate a strategic assessment of each program's first quarter performance. The program evaluation team will conduct site visits and administer surveys to better inform reporting.

By using evidence in all SLFRF-related projects and programs, program staff can better assess and improve the project baselines, resulting in a greater long-term impact for those served, and a higher level of goal achievement. The use of evidence is founded through four stages; evidence is collected at each stage and supports the progression to the next.

### Stage 1: Exploratory

The initial stage of Tarrant County's use of evidence involved exploring the relationship between established target outcomes and the type of resources needed to serve both constituent and stakeholder interests. In this stage, Innovative Emergency Management (IEM), a consulting firm, was engaged to conduct a countywide needs assessment. Evidence collected during the needs assessment allowed the Commissioners Court to make an informed decision about how best to align the identified community needs with the statutory eligible uses.

In this stage, the evidence is descriptive in nature as the Commissioners Court members and administrative-level stakeholders generated ideas and constructed a proof of concept. The resulting COVID-19 Needs Assessment Final Report provided a wealth of qualitative and quantitative evidence through interviews, focus groups, roundtables, and surveys.

### Stage 2: Development

Based on the findings of the needs assessment, County staff created a process to engage in continuous feedback between SLFRF subrecipients and the ARPA evaluation team. Periodic meetings are held with all SLFRF subrecipients to allow for the collaborative development of evaluation metrics (i.e., outputs, equitable outcomes) to measure against the county's overarching Focus Area outcomes.

Each quarter, evidence is collected to ensure subrecipient alignment with the Focus Area outcomes. The program evaluators utilize evaluative questions and supporting data to facilitate further decision-making at the project level. For instance, the program evaluation form was tested for use during the first performance evaluation discussion with each subrecipient. Through these discussions, the ARPA program evaluation team used the evidence to design a process whereby present and foreseeable reporting challenges could be addressed and revised prior to summative evaluation.

With the developed use of evidence process and protocols, the evaluation team analyzes the subrecipient deliverables from their monthly metric reporting. The ARPA evaluation team can clearly define the intervention at the County level and then define observable features of program implementation to determine whether the key deliverables produced lead to the Focus Area outcomes at the project level.

### Stage 3: Efficacy

During the efficacy stage, the ARPA evaluation team uses the following questions to guide the use of evidence:

1. Is the program sufficiently developed and feasible?
2. Is it possible to collect relevant and reliable data?
3. Does the subrecipient have a viable outcome measurement tool?
4. Do the outcomes at the subrecipient level align with the Focus Area goals?

The above questions guide the generation of independent evidence of each program's effect for each quarterly report to the U. S. Department of the Treasury. In the first two quarterly reports to Treasury, the team provided a formal report of each program's eligible use of funds based on evidence from the time of program implementation. This evidence will be used in a summative assessment at the end of the contract period to show the efficacy of the program and the effectiveness at the County level.

Internal programs and external subrecipients are asked to identify whether they are relying on evidence-based interventions as a basis for their programs. Several County departments are implementing programs and facility improvements based on evidence from trade group advisories, studies and Centers for Disease Control and Occupational Safety and Health Administration guidance. External subrecipients that are implementing an evidence-based intervention are asked to submit studies and research related to that intervention. As part of the County's community call for proposals, applicants were required to select whether their program was an evidence-based intervention and, if so, to submit additional information.

### Stage 4: Scale-up

One of the primary purposes of awarding subrecipients SLFRF dollars is to ensure that their programs will continue to make a positive impact in Tarrant County long after the funding period has ended. At the scale-up stage, the County will generate estimates of program impact based on evidence garnered during the evaluation period. At this stage, the evidence should provide empirical context to support why and how the programmatic outcomes substantiate the established Focus Area outcomes. To ensure the fidelity of the empirical evidence, programmatic outcomes will only be used if they attribute to the overarching Focus Area outcome. Here, the team will use a quasi-experimental design to establish a causal relationship between the Focus Area outcome and the public value aim.

The Tarrant County Emergency Rental Assistance Program (ERAP) is designed to assist eligible households who are unable to pay rent and/or utilities due to the COVID-19 pandemic as established by section 501 of Division N of the Consolidated Appropriations Act, 2021 (ERA 1) and Section 3201 of Subtitle B, Title III of the American Rescue Plan Act, 2021 (ERA 2).

Assistance may be provided for unpaid, overdue rent (arrears) from April 1, 2020, and for future rent. Using a combination of ERA 1 and ERA 2, total months of assistance is not to exceed 15 months, or 18 months, if necessary, for housing stability as defined by US Treasury.

If applicant/household is eligible, assistance will be provided as follows:

- Rent arrears plus three months in future rent, for a total of up to 15 months
- Rent arrears plus three months in future rent, for a total of up to 18 months if more than 12 months in arrears exists at time of application
- Arrears only if 18 months in arrears exists at time of application
- Utility arrears plus current month utility expense if applicant provides current month's utility bill
- Additional assistance may be provided for future rents in three-month increments or utility payments one month at a time as outlined in Income Determination section.

## Public Health

### *Programmatic Data*

To effectively respond to the COVID-19 pandemic, Tarrant County Public Health (TCPH) implemented multiple COVID-19 prevention, mitigation, and intervention strategies. The strategies included: public education and outreach, testing, vaccination, as well as case surveillance and contact tracing. Funding for these interventions leveraged multiple grant streams including the following:

The following represents a high-level summary of prevention, mitigation and intervention strategies implemented beyond those funded solely by SLFRF since the start of the pandemic. In most instances, funding represents a blending of the aforementioned grants to maximize impact and leverage the funding available at the time during the pandemic.

To increase access to immunizations, COVID vaccinations were offered free of cost during TCPH routine clinic hours, during extended evening and weekend clinic hours, as well as at pop up clinics in the community. Between April 1, 2021 and June 30, 2022, a total of 2,261 clinics were conducted with 30,102 doses of COVID-19 vaccine provided. Of those clinics, 566 were at 229 locations within the community.

To reach individuals with the highest risk of mortality from COVID-19, 338 community clinics, or 60% of mobile clinics, were held in census tracts with high Social Vulnerability Index (SVI) scores. TCPH department partnered with the following organization types to conduct clinics; churches, municipalities, community events, FQHCs, homeless shelters, businesses/manufacturers, long-term care providers, non-profits and school, and child-care providers.

Note: Mass clinic operation during Phase I of the pandemic was supported with CARES funding and is therefore not included in the numbers provided.

## ARPA Programs Other Than SLFRF

Multiple activities were undertaken to increase access to timely and accurate information about COVID-19 and to combat COVID-19 misinformation.

**Health Promotion Campaigns:** Two separate health promotion campaigns were conducted. The first utilized social media and radio to raise awareness about COVID-19, testing and vaccination. The second utilized influencers using their social media networks to talk about their own COVID-19 vaccination experiences.

**To Canvassing/Health Education Events:** Outreach staff canvassed areas prior to clinics, knocking on doors to make sure residents are aware of upcoming clinics. TCPH also staffs educational booths at health fairs and other events to share information about clinics as well as general COVID-19 information.

**Call Center:** A call center was established to take informational calls from the public, assist individuals with making appointments to get vaccinated and obtain vaccination records. The call center also provided individuals who the department tested for COVID-19 with their test results. The call center conducted outreach to persons who were due or overdue for vaccination. In all between June 1, 2021 and June 30, 2022 the call center placed or received more than 130,887 calls.

**Mass Messaging:** Automated texts and phone messages were sent to anyone who signed up for a COVID-19 vaccination, and anyone who was due or overdue for a second dose or booster. In all, 3,357,046 automated messages were sent between June 1, 2021 and June 30, 2022.



Early case identification remains an important testing strategy. While mass testing is funded under SLFRF, small volume testing is done at TCPH clinics and analyzed in our labs, providing an expedited pathway for testing persons with a high index of suspicion. From program inception in August 2021 through the end of June 2022, a total of 8,934 individuals have been tested. Of those tested, 3,139 were positive for COVID-19, a positivity rate of 35%.

## ARPA Programs Other Than SLFRF

Another facet to the Tarrant County Public Health's COVID-19 response was surveillance and case/contact tracing. To date, more than 590,000 confirmed or probable cases of COVID-19 have been reported, including 5,965 deaths. Information about each case is entered into an electronic disease surveillance system and information about those cases is published routinely to the department's online public dashboard. A team of investigators is dedicated to helping mitigate spread among high-risk populations such as long-term care facilities, childcare facilities and schools. Other teams are assigned specific cases, contacts, and deaths for investigation.

The pandemic emphasized the need for a robust, modern, interoperable and secure public health data system that delivers real-time, accurate, and actionable data. While the procurement of systems is being funded through SLFRF, the identification and maintenance of staff to lead and coordinate data modernization efforts has been funded largely from CDC or locally funded efforts. Data modernization efforts have focused on electronic disease and lab reporting, data governance, and data visualization.

Other projects undertaken by the department, or its partners aim to address the root cause of the disparities in outcomes related to the pandemic, by focusing the social determinants of health. Projects include linking individuals to insurance and/or primary care or other social services, developing and implementing social equity plans, and training community health workers.

The pandemic response took a toll on the public health workforce. Efforts of the DSHS-CDC workforce grant are focusing on developing positive department culture and fostering department wellness. To achieve this, activities to date have centered around assuring all Tarrant County Public Health staff are trained in the following:

- **Trauma Informed Care**
- **ACES**
- **Unconscious / Implicit Biased**

## Community Development

### The HOME Investment Partnerships American Rescue Plan Program (HOME-ARP)

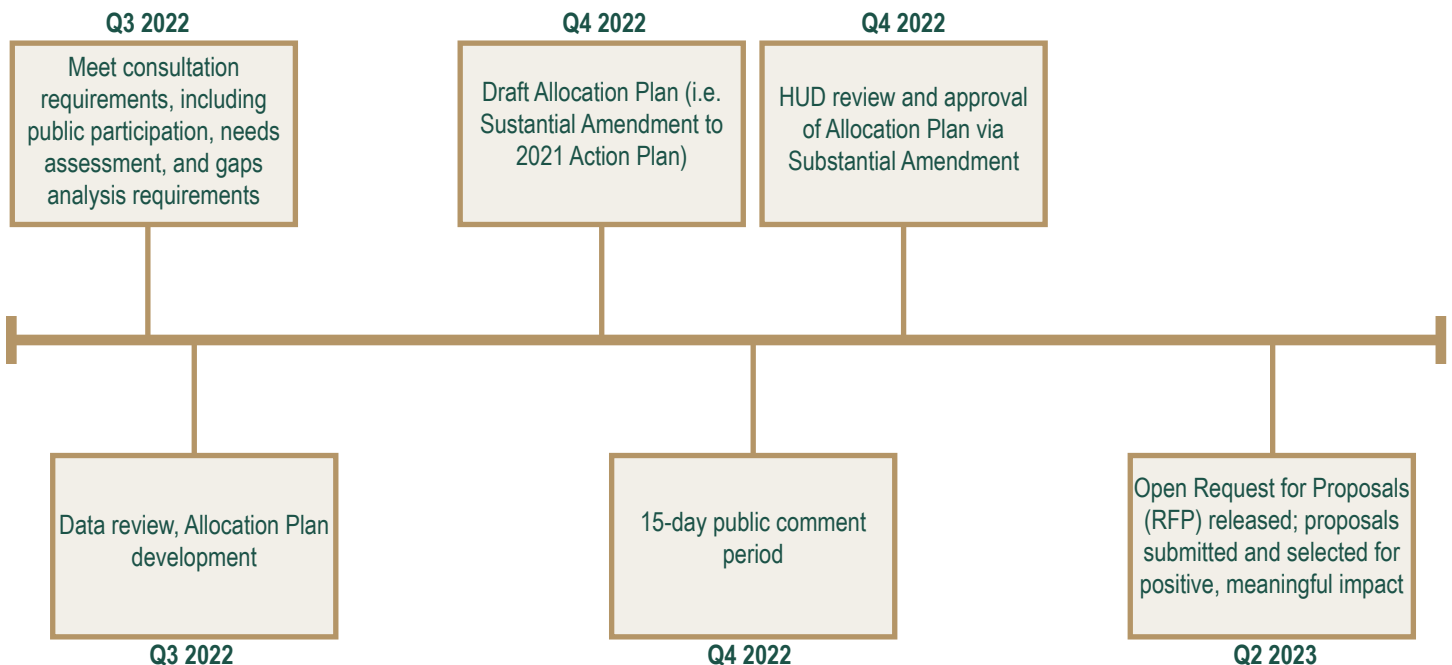
Tarrant County plans to use its HOME-ARP allocation to provide housing assistance to qualifying populations (QPs) of County residents. Housing assistance will consist of several services and programs including the production or preservation of affordable housing, tenant-based rental assistance (TBRA), supportive services, homeless prevention services, housing counseling, and the purchase and development of non-congregate shelters. HOME-ARP will provide access for all QPs to apply for or be referred to projects or activities associated with the program.

The County may provide housing assistance to the following QPs:

- those experiencing homelessness or at risk of homelessness
- those fleeing or attempting to flee intimate partner violence, sexual assault, stalking or human trafficking
- populations where assistance would prevent a family’s homelessness or serve residents with the greatest risk of housing instability.

Tarrant County is currently in the consultation phase of the planning process for HOME-ARP. As part of this phase of the planning process, the County will consult with various community stakeholders including veterans’ groups, homelessness and domestic violence service providers, public housing agencies, and continuum of care organizations, along with various public and private organizations addressing fair housing, civil rights and the rights of persons with disabilities.

The County also plans to complete a Needs Assessment and Gap Analysis to determine the unmet needs of each QP. Qualitative and quantitative data are being collected through HUD, my Sidewalk, CoCs, partners, surveys, stakeholder interviews, and other methods to meet the needs specified in the HUD Notice.
