## **Summary**

# **Call for Proposals: Community Programs**

Tarrant County requested proposals for projects from nonprofit, local government, and guasi-governmental agencies that respond to the focus areas and goals guiding the County's response to the COVID-19 pandemic. Proposals were accepted in the following areas: Revitalize the Economy; Strengthen the Community; and Improve Public Health and Wellness. \*Note: The application window closed on Monday, May 16 at 5:00. 131 applications were received with a total request amount of \$208 million. The county's evaluation committee has begun the proposal review and scoring process.


