In accordance with Local Government Code, Sec. 112.006, General Oversight Authority of the County Auditor, the Auditor's Office performed a review of the controls over the Constable's property room as of February 27, 2013. The objective of the review was to determine whether property held by the Constable's Office was properly recorded and secured. The Auditor's Office observed one condition related to the disposition of three items held in the property room since 2010. The Auditor's Office discussed this condition with the Constable.

Re: Auditor's Report - Review of Constable, Precinct 4, Property Room

SUMMARY

In accordance with Local Government Code, Sec. 112.006, General Oversight Authority of the County Auditor, we performed a review of the controls over the Constable's property room as of February 27, 2013. The objective of our review was to determine whether property held by the Constable's Office was properly recorded and secured. We observed one condition related to the disposition of three items held in the property room since 2010. We discussed this condition with the Constable during the time of our review. Attached is his written response.

OBSERVATION AND RECOMMENDATION

Three weapons had remained in the property room since 2010.

During the course of normal duty, a peace officer may obtain items such as weapons, ammunition, drugs, and drug paraphernalia. When this occurs, the peace officer, in this case the Constable's Office, retains custody of the property until further orders are received from a magistrate. The Code of Criminal Procedure provides guidance for the safeguarding and the disposition of seized, forfeited, and unclaimed property held by a peace officer.

We observed three weapons that had been in the property room since 2010. According to Constable staff, the owner of two of the weapons was deceased. Certified letters were sent the deceased owner's family, but they were not interested in claiming the weapons. The third weapon was seized on an execution. When Constable staff communicated with the owner in 2010, the owner requested that the weapon be held.

Recommendation

In accordance with Code of Criminal Procedure, we recommend that the Constable obtain a judicial order for the disposition of the property since the weapons have remained unclaimed since 2010.
