RE: Auditor's Report – District Clerk, Felony Civil Section

SUMMARY

In accordance with Local Government Code, we reviewed the various fees assessed by the District Clerk's Felony Civil Section and performed selected test of controls over the bond forfeiture process for the nine months ended June 30, 2016. As a result of our review, nothing came to our attention to indicate any material control weaknesses related to the processing and recording of receipts.

BACKGROUND

Both the District Clerk's Office and the Criminal District Attorney's Office have certain responsibilities related to the bond forfeiture process. The District Clerk has a ministerial role with regard to bond forfeitures. Other responsibilities of the Felony Civil Section include accepting petitions and payments for certain post-conviction matters (e.g., Expunctions, Nondisclosures). During our review period, staff collected approximately \$700,511 of which \$385,483 specifically related to the bond forfeiture process.

When a defendant posts bond for release from jail, he or she agrees to certain conditions including an appearance in court. The failure to perform any of the conditions on the bond causes the court to declare forfeiture of the bond. The judge enters a "NISI judgment." A NISI judgment will be made final unless good cause is shown as to why the defendant did not appear in court. Although bond forfeiture is considered a criminal case, the bond forfeiture proceedings are governed by the rules for civil lawsuits. Upon notification from the Criminal District Attorney, the District Clerk's Felony Civil Section staff prepares the court order paperwork that specifies the amount of forfeiture, court costs and sends the final judgment to the judge for signature.
