It's been our pleasure to bring you into the somewhat confusing and unknown world of County Government. The question I get asked more than anything is: "What does a County Commissioner do?" We have tried to answer that question this past year.

Let me share with you what a Commissioner Doesn't Do or Can't Do...based on actual requests....

- No authority concerning school districts
- No authority over any action by a City Council.
- We don't set property appraisals.
- We don't become involved in homeowner association disputes.
- We can't make your neighbor move his pigeon coop away from the fence separating your property.
- We can't remove the raccoon from your attic.
- We can't re-zone your property, your neighbor's property or any property.
- We don't remove beehives from your home or property.
- We can't get your traffic ticket fixed in any of our cities
- We can't get the District Attorney's office to remove your brother's DWI.
- We don't provide trash collection service.

**BUT**, if you have problems or situations in which you cannot find help, call us. We

will listen and try our best to send you in a direction for help and assistance.

Next, we have good news and bad news on the transportation front. Good news first: Public hearings have taken place on the financial portion of both the North Tarrant Expressway and the DFW Connector projects. All public comments were positive on both projects. Construction should start in early 2010 on both projects. Bad news: The North Texas effort to give the voters of our region the opportunity and option to select needed transportation projects and select a funding source failed to pass in the Legislative session that ended June 1. What does this mean for our area? It means that the traffic congestion and transportation problems will not go away, and in the future will only cost more money to solve. The DFW region has the worst traffic congestion in the United States and NETC has the worst traffic in the Metroplex! What do you think? What would be your suggestions as to resolving the traffic issues? I would like to hear your input.

# Employee Spotlight



**G.K. MAENIUS**



**TARRANT COUNTY ADMINISTRATOR**

G. K. Maenius has served as County Administrator for over 21 years. Prior to joining the County in 1988, G.K. was the Senior Vice President for Governmental Affairs for the Fort Worth Chamber of Commerce. In that role, he also served as the Executive Director of the Fort Worth Crime Commission. Prior to coming to the Fort Worth area in 1982, G.K. worked in the Governor's Office as Program Director of the Texas Organized Crime Prevention Council. While working towards his Bachelors and Masters degrees, he worked for the Texas Crime Prevention Institute and was a police officer.

G.K. is married to Lynda and has two sons – Chase and Ross. He has a grandson (William) who lives with his father and

mother (Chase and Shannon) in Los Angeles, CA. G.K. was born and raised in the Texas Hill Country around the Fredericksburg area. His father and mother still run their ranch which is close to the LBJ Ranch. He states that his eventual goal is to go back to that area and enjoy the hills.

As the County Administrator, G.K. serves as the chief administrative officer for the Commissioners Court. He supervises all departments that are under the control of the Court. Additionally, the Administrator's Office serves as the planning and management arm of the Court. Other areas included within his Office are economic development, community development, criminal justice management, communications and marketing, public information, re-entry programs, legislative coordination, grant administration and emergency management.

Besides county activities, G.K. is currently focusing on two additional things. First (and foremost), is to figure out a way to get his grandson to Texas. He says that it doesn't matter if Chase and Shannon

move or not, just send William. Second, he is trying to improve his golf game. He may be the worst golfer currently employed by the county. With the addition of the City of Saginaw in 2004 ARTSNET is now recognized by the TCA as the arts council representing North Tarrant County. Over the past 32 years, ARTSNET has consistently and tirelessly worked in partnership with many of the cities, School Districts, Eight Chambers, PTAs, Summer Santa, Christ Haven, Women's clubs and businesses in North Tarrant County to develop a better understanding of the value of the Arts.

ARTSNET has brought the Arts to North Tarrant County for over 34 years.

Programs encompass:

- K.E.Y.S. (Knowledge, Education, Youth, Success!) to Art – A visual arts program
- Summer Arts College –serves over 500 children ages 6-11, including one teen camp ages 12-15
- Art for Veterans - the first art program in the state of Texas geared specifically towards veterans
- MasterWorks Concert Series –reaches more than 20,000 people and is free and open to the public
- Classes - including drama, voice, dance, piano, multi-media art, porcelain and guitar are taught by experienced teachers and artists.
- Grants- for schools, non-profit organizations, and cities to bring the arts to their communities.

In partnership with the Texas Commission on the Arts, ARTNSET has generated over \$1.3 million in grants.

ARTSNET also holds an annual fundraiser called Taste of Northeast where local restaurants and eateries come together to show off their many flavors. This fundraiser includes a silent auction, raffle drawing and big board. (See below)

## H1N1 Influenza Virus (Swine Flu)

H1N1 Influenza Virus Infections by Cities in Tarrant County 4/25/09 through 6/05/09

"I never know when it will happen, and I never know what it will be. But as I gathered with other members of the Tarrant County Public Health team on Sunday, April 26 to meet about our new nemesis, H1N1 (swine) flu, it had a familiar feel," recalls Tarrant County Public Health Director Lou Brewer. "Most recently, we had dealt with a CRYPTO outbreak, a *Salmonella* Saintpaul outbreak and hurricane evacuees."

At our meeting that Sunday, we pulled together information about what was going on nationally and regionally; we referred to our pandemic influenza response plan, and we talked about what we might need to communicate locally to our medical partners, the community and others. Among the first things we do is share information with the medical community so that they will know which symptoms to look for. We determined the need for a bilingual hotline, which was up and running by Monday, and we posted information on our Web site and distributed it to the media. Our weekend team accomplished the tasks at hand. Just to give you an idea of the team's makeup: health director, medical director/health authority, public information officers, chief epidemiologist, associate director of prevention and public health planning and our

associate director of community health. By Monday, we were investigating our first probable H1N1 (swine) flu case in Tarrant County.

By May 1, there was a local school closure. In situations such as this, our role in school closures begins by working closely with school officials, using the most current local data and any related state or federal guidelines to help us make a recommendation. Rapid changes locally and nationally precipitated the addition of daily media briefings to help get info to the public.

As of June 5, we were still confirming H1N1 (swine) flu cases in Tarrant County. One important change is that our North Texas Regional Laboratory was certified on May 18 to perform confirmatory testing for H1N1 (swine) flu. This change was a newly authorized capability. Previously all samples had to be sent to Centers for Disease Control and Prevention in Atlanta. Beyond that, our process since the event started has been to test the samples, investigate each case, make contact with the people affected and report the information to the public. 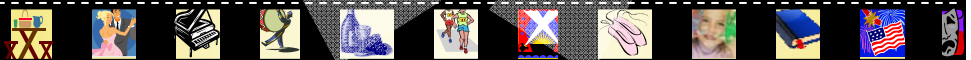

## Business Improvement & Growth Program

The Business Improvement & Growth Program, otherwise known as B.I.G., is a City funded program that provides technical and financial assistance to independent businesses seeking to renovate and restore their exterior appearance.

B.I.G. Coverage Area and Business Eligibility:

- Located in North Richland Hills
- Located south of Mid Cities Boulevard
- Storefronts facing Boulevard 26, Davis Boulevard, or Rufe Snow Drive

The Program Provides for:

- A matching grant for storefront improvements up to \$10,000
- A matching grant for a new monument sign up to \$3,000
- Provides up to \$2,000 for removal of non-conforming pole sign
- Technical and design assistance for FREE

This adds up to a possible value of \$15,000

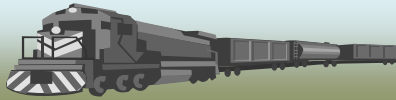

We have completed the crack sealing operation for the year and have started mowing the right-of-ways and improving storm water drainage ditches for the summer.

Since the beginning of our fiscal year on October 1<sup>st</sup> we have completed numerous city and county projects. Some of our projects were asphalt overlays to prevent deterioration of the road, and others have included total rehabilitation of the road to strengthen the road base and improve the driving surface. We are currently working on road rehabilitation in the City of Colleyville and the City of Keller, with many other roads and cities planned for the remainder of this fiscal year.

# An Historical Moment In Time



## Historic Smithfield

First settled in the mid-1800's , the area known as Smithfield was largely a farming community producing cotton, wheat, oats, berries, grapes, plums, peaches, corn and cattle. One of the grandest events in Smithfield's history was the arrival of the Cotton Belt Railroad in 1887. The tracks bypassed the Smithfield business district by about a quarter mile. Undaunted, storekeepers and others moved their buildings southward, and a new business district was established near the train depot.

The railroad fare from Smithfield to Fort Worth was 35 cents and the trip took about an hour to cover the 18 or 19 miles in good weather. The train stopped twice a day, at 10:10 in the morning going southwest to Fort Worth and at 10:10 at night going to points east such as Plano and Greenville. The morning stop in particular attracted townsfolk who would gossip and collect news from the conductor. The railroad opened up potential for commercial development and in the late 1880s Smithfield received its first real industry - the Smithfield Canning Factory. The factory employed 20 to 30 women and children who canned tomatoes, corn, peaches and peas grown by area farmers.



The Smithfield area flourished after the Cotton Belt Railroad arrived in 1887. Today, the City of North Richland Hills is working to bring a new commuter rail service to the community.

Today, Smithfield is part of the City of North Richland Hills. The rail line is still there and the City is working to bring a new commuter rail service to the community as part of the Southwest-to-Northeast Rail Corridor. This service would run from southwest Fort Worth, through downtown Fort Worth, Haltom City, North Richland Hills, Colleyville and Grapevine to the Dallas Fort Worth Airport. Two stops are planned in North Richland Hills: one on Iron Horse Boulevard near Loop 820, and one near Main Street and Davis Boulevard in Smithfield. In addition to providing alternate transportation for commuters, City leaders believe the rail stations will help stimulate economic development in both areas. New transit oriented development codes will govern future development around the rail station sites and will help in preserving the historic nature of the Smithfield area.

1938 - 2009

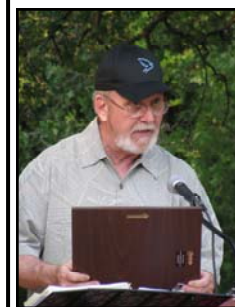

# Northwest ISD: In the Business of Building Futures

Keeping the philosophy that Northwest must retain the best teachers in order to become the best district, the NISD Board has steadily increased salaries over the last 10 years, raising the beginning salary from \$30,000 to \$47,500.

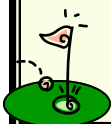
