## **INFORMATION FOR RENTERS**

Effective March 17, 2020, all scheduled Tarrant County court proceedings (including motion hearings and trials) except for those deemed "essential court proceedings", such as Emergency Mental Detention Warrants, Writs of Reentry, Writs of Retrieval, and certain Repair and Remedy cases, are suspended until further notice. In Eviction cases, no writs of possession will be issued by the Court until the Court receives a new directive.
