### Week 19 Summary

- 125 mosquito pools\* have been tested in NTRL from week
  - Year-to-date NTRL has tested a total of 748 mosquito pools
- 0 mosquito pools tested positive for WNV this week:
- There have been 0 imported human cases of SLE or Zika in 2023. There have been 0 cases of Dengue Fever.
  - There have been 0 human cases of West Nile disease.



Figure 1. Average Number of Female *Culex* Species Per Trap and Vector Index by Collection Date, Tarrant County, 2022-2023


