Weekly Arbovirus Surveillance Report: MMWR Week Jul 30-Aug 5, 2023



### Week 31 Summary

- 177 mosquito pools\* have been tested in NTRL from week
  - Year-to-date NTRL has tested a total of 2857 mosquito pools
- 20 mosquito pools tested positive for WNV this week:

Arlington (7) Bedford (2) Euless (2) Fort Worth\* (3) Grapevine (2) Hurst (1) Keller (1) Mansfield (1) Southlake (1)

- There have been 0 imported human cases of SLE or Zika in 2023. There has been 1 case of Dengue Fever.
  - There have been 3 human cases of West Nile disease.
- Average number of mosquitoes/trap include:



Figure 1. Average Number of Female *Culex* Species Per Trap and Vector Index by Collection Date, Tarrant County, 2022-2023


