Loomis Armored US, Inc. did not agree to Cooperative Purchasing because they can not agree to offer the same pricing to locations that may be 100 to 150 miles away from a Loomis branch. Loomis Armored US, Inc. later agreed in writing to extend pricing under this contract to Cooperative entities within twenty five (25) miles of the Loomis Armored branch.
