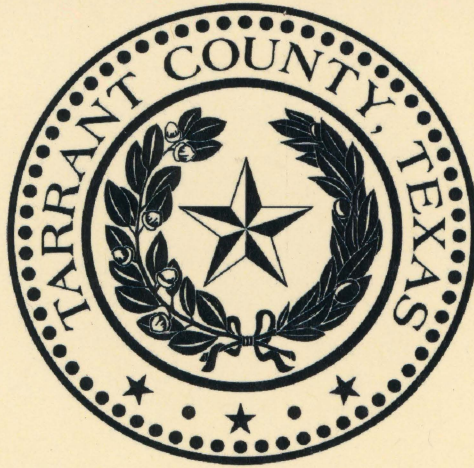

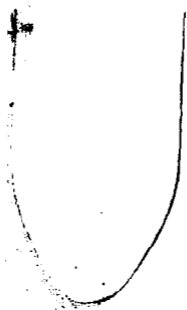

SYNOPSIS OF LAWS

Passed by the Sixty-ninth Legislature

SECURING COURSE OF PROCEEDINGS

Revised civil rules, article 1401, amended so that on a writ of habeas corpus may be contested by officers of the court, and the issue tried as to ability of the party to give bond for costs.

Article 1420 (a) reads: It shall be lawful for clerks of the district and county courts and justices of the peace to demand payment of all costs due in each and every case pending in their respective courts up to the adjournment of each term of said courts.

Article 1420 (b) provides ten days after such demand the clerk or justice may place certified copy of bill of costs then due in hands of the sheriff or constable for collection, which shall have force and effect of an execution. Taking an appeal does not interfere or suspend the right.

Article 1420 (c) authorizes levy and sale, but no costs or charge allowed for making out certified bill of costs or for collection unless levy is made.

Article 1433. Requires, when oath is made, that party is too poor to pay costs or give security, all process shall issue until the oath is contested and the issue tried at the next term after filing the contest.

Article 2385. County judge receives fee of \$3 for every cast of lunacy he disposes of; same fee for each civil case disposed of; when party cast in costs made oath too poor to pay county commissioners, shall allow the county judge such fee, not to exceed \$3, as may deem proper.

Article 2389. District clerks fees.

For copy of petition, including certificate and seal, 20 cents per 100 words; writ of citation, 75 cents; docketing each cause, 20 cents; docketing rule or motion, 15 cents; filing each paper, 15 cents; entering appearance of each party, 15 cents; each continuance, 20 cents; swearing witness, 10 cents; oath, with certificate and seal, 50 cents; each subpoena, 25 cents; each additional name in each subpoena, 15 cents; approving bond, except for costs, \$1.50; swearing jury, 35 cents; receiving and recording verdict, 35 cents; assessing damages in case not tried by jury, 50 cents; commission to take depositions, 75 cents; taking depositions, 15 cents per 100 words; each order, judgment or decree, 75 cents; when judgment or decree exceeds 200 words, 15 cents for each additional 100 words; each execution or other writ not otherwise provided for, 75 cents; recording return of writ 75 cents; certificate of facts contained in records, 75 cents; cost of making out and transmitting records, etc., to inferior court 20 cents per 100 words; mandate of district court upon appeal, \$1; filing record in appeal to district court, 50 cents; transcribing, verifying, etc., record books of his office, payable by county, 10 cents per 100 words; transcript on appeal or writ of error; with certificate and seal, 20 cents per 100 words; copy from records for party applying, 20 cents per 100 words; writ of scire facias and copy, \$1; taxing bill of costs and copy, 25 cents; issuing license to attorney and recording same, \$5; filing and recording declaration of intention to naturalize, \$2; issuing certificate of naturalization, \$2.50

Article 2392. District clerk may be allowed pay deemed proper by county commissioners for care and preservation of records, and keeping indexes.

Article 2395. County clerks, except for costs in suits pending in county courts, may be allowed for ex officio services not to exceed \$100 annually.

Article 2396. Sheriff's fees—Serving original citation in civil suit, \$1.50; summoning witness, 50c; levying and returning writ of citation or sequestration, \$2.50; serving writ of garnishment or other process not otherwise provided for, \$1.00; taking, returning, and approving each bond, \$1.00; indorsing forfeiture of any bond, 50c; levying execution, \$1.50; returning execution, 85c; executing and returning writ of possession or restitution, \$3.00; advertising order of sale, \$1.00; posting other legal notices, \$1.00; executing deed, \$3.00; bill of sale, \$1.00; jury fee, 50c; for designating a homestead, \$2.00; mileage in civil cases, 5c. per mile going and coming; collecting money under execution, when by sale, 4 per cent. for first \$100 or less, for second \$100 2 per cent., and over that 2 per cent.; when collected without sale one-half of above rates; attending district or county court, \$3.00 per day. Article 2428 provides that the foregoing fees do not apply in cases of costs against estates of deceased persons and

Section 21 of act regulating duties of tax collectors in reference to sale, etc., of property of delinquents, is amended to read:

"Should the collector of taxes fail to make sale of any real estate for want of a purchaser, he shall give notice to the bystanders that he will, on the first Monday of the following month offer said unsold lands for sale, and continue the sale from day to day for six successive days, after which, should there be any unsold lands, he shall report the fact to the comptroller, and shall have a credit for the amount assessed on said lands in a settlement of his account; and such lands as are not sold shall remain in the hands of collector, and the owner may pay the amount due on said lands, with interest at the rate of 8 per cent per annum from date of sale, with accrued costs; or any other person, on the failure of the owner to thus redeem said lands, shall have the right to pay the amount due on said lands, with interest and costs." Remainder of section provides for deed by the collector, and right of owner to redeem in two years.
