# The law west of Dallas: Mahon recognized as a 'living legend'

**FORT WORTH** — Senior U.S. District Judge Eldon Mahon now adds "legend" to list of accolades he has received in the 60-plus years since he stopped chopping cotton in West Texas and headed for college and law school.

Mahon has been named a "living legend" by *Texas Lawyer* magazine, which asked lawyers across the state for nominees. Magazine editors made the final cut for a special edition called "Legal Legends: A Century of Texas Law and Lawyering."

Mahon is the only Fort Worth attorney on the list; 19 lawyers and legal scholars from Dallas are listed.

"I really feel in good company," Mahon said yesterday. "It's a great honor. I knew many of these lawyers. Some were my law professors at the University of Texas."

At 82, Mahon goes to his office at the federal courthouse every day. He could have fully retired long ago but continues to work as a senior judge, carrying a reduced caseload.

And he still relishes his job.

"The federal bench is the best position in the federal government because of your independence," Mahon said.

In highlighting his accomplishments, *Texas Lawyer* said, "Mahon has presided over the racial trials and tribulations of the Fort Worth school district, over-

seeing issues such as busing of students for racial integration, for about 15 years."

Mahon took over the school desegregation case from senior U.S. District Judge Leo Brewster and oversaw the case from 1975 to 1990.

"I feel more satisfied about the progress we made within the Fort Worth school district than with anything else that I dealt with in court," Mahon said.

Mahon grew up on his father's cotton farm in Loraine in Mitchell County. "I remember they used to close the schools for two to four weeks during the harvest so the kids could help out on the farms," Mahon said.

A 1942 graduate of the University of Texas School of Law, Mahon served in the South Pacific with the Army Air Forces in World War II.

After the war, he started out as a briefing attorney for the Texas Supreme Court.

He won election as Mitchell County attorney, was appointed district attorney for the 32nd Judicial District, covering Nolan,

Mitchell, Scurry and Borden counties, and he prosecuted crooks for 13 years.

In 1961, Mahon became a district judge but resigned after three years. The reason: money. The job paid \$12,000 a year, not enough to support a family with three children, Mahon said. He went on to take a position as vice president of Texas Electric Service Co. in Fort Worth.

A year in the corporate world was enough for Mahon to realize that the law was more to his liking. In 1964, he became a partner in the Mahon, Pope & Gladdon law firm.

Four years later, President Lyndon B. Johnson appointed him U.S. attorney for the Northern District of Texas. When Republican Richard Nixon won election as president, he not only kept Mahon as U.S. attorney, but in 1972 he also elevated the Democratic appointee to the federal bench. Mahon took senior status in 1989.

### John P. Newport



**FORT WORTH** — Dr. John P. Newport, vice president for Academic Affairs and provost, Retired and Distinguished professor of Philosophy of Religion, Emeritus, at Southwestern Baptist Theological Seminary died Friday, August 18, 2000, in Fort Worth.

Dr. Newport was born June 16, 1917 in Buffalo, Mo., and reared in Springfield, Mo. He graduated from William Jewell College in Liberty, Mo., and earned a ThM and ThD from Southern Baptist Theological Seminary, an M.A. from Texas Christian University, and a Ph.D. from the University of Edinburgh. He studied at the University of Basel, the University of Zurich, Columbia University, Union Theological Seminary (New York), University of Tulsa, Tulane University and Harvard University (Rockefeller Foundation Fellowship).

He served as pastor of four churches including First Baptist Church in Clinton, Miss., and Immanuel Baptist Church in Tulsa, Okla. In addition to his service at Southwestern Seminary, which began in 1952, Newport was a professor at Rice University (The Chavanne Chair of Religious Studies in 1976-79), an Associate Professor at Baylor University (1949-51), an Associate Professor at New Orleans Baptist Theological Seminary (1951-52), a Visiting Professor at Princeton Theological Seminary (1982), a Rockwell Visiting Theologian at the University of Houston (1984, 1992), and a visiting professor at Golden Gate Baptist Theological Seminary. He has presented formal lectures in more than 100 academic institutions and at numerous conferences, including ecumenical and interreligious dialogues. He and his wife conducted multiple lecture tours in Europe, the Middle East, the Far East, and South America.

Newport published 11 books, including "Demons, Demons, Demons" (1972), "Paul Tillich" (1984), "Life's Ultimate Questions: A Contemporary Philosophy of Religion" (1989), and "The New Age Movement and the Biblical Worldview: Conflict and Dialogue" (1998). He had memberships in the American Academy of Religion (president, Southwest Division, 1967-68), Evangelical Philosophical Society, Gallup International Institute, National Association of Baptist Professors of Religion (president, 1991-92), the North American Paul Tillich Society (director, 1984-86), and the Southwestern Philosophical Association. He was listed in the Directory of American Scholars, Dictionary of International Biography, International Book of Honor, Personalities of the South, Who's Who in American, Who's

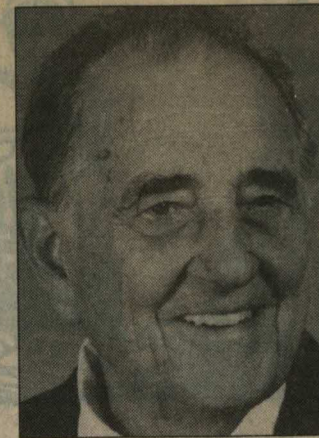

For the lifetime which he devoted to the service of God and mankind, and an unqualified love of family, friends and life and its living, Wesley D. Sears will never be forgotten.

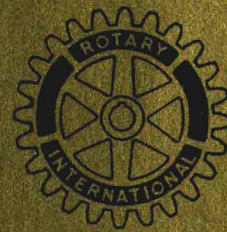

# Bylaws

(Revised to be effective 1999-2000 Club year)

Note: The following documents are copied as submitted by the Bylaws Committee.

## ARTICLE I

### Name

**Section 1.** The name of this organization shall be "The Women of Rotary of Fort Worth".

## ARTICLE II

### Object of Organization

**Section 1.** The object of this organization shall be to encourage close friendship between families of members of The Rotary Club and to cooperate in any social, philanthropic or educational work upon which the body may decide.

## ARTICLE III

### Membership

**Section 1.** The wife of an active or honorary Rotarian or a widow of same is eligible for membership.

**Section 2.** With approval of the executive Board a member with fifteen or more years of service who is unable to attend meetings may be proposed to the president in writing by the April general meeting. Honorary members will be exempt from annual dues, and are subject to review each year in April by the president, the treasurer and the membership chairman.

**Section 3.** In the event of cessation of membership of a member Rotarian except by death, membership of the wife shall cease at the end of the current year.

**Section 4.** Annual dues shall be twenty-five dollars payable April 2 and shall be delinquent if not paid by June 1. One third of annual dues shall be used for club's special funds project.



**Section 5.** New members shall pay dues upon joining the organization. Members joining after January 2 shall be required to pay only half of annual dues.

**Section 6.** The fiscal year shall begin June 1.

#### **ARTICLE IV**

##### **Offices and Their Election**

**Section 1.** The officers shall be president, first and second vice-president, recording secretary, corresponding secretary, treasurer, historian, parliamentarian and directors.

**Section 2.** A nominating committee of five members shall be appointed by the executive board at its December meeting and announced at the following general meeting. They shall present a list of nominees for the annual election in March. Additional nominations may be made from the floor.

**Section 3.** Election shall be by ballot; except when there is only one nominee for an office, the election shall be by voice. A majority will elect.

**Section 4.** Term of office for treasurer and directors shall be two years, with one director retired each year. Term of office for other officers shall be one year.

**Section 5.** A vacancy in office shall be filled by the executive committee.

**Section 6.** Officers shall assume office the first Thursday in May and serve until their successors assume office the following May.

**Section 7.** The president shall preside over all meetings of the club and appoint all committees except the nominating committee. She shall be custodian of past records and reports.

**Section 8.** The first vice president, in the absence of the president, shall perform all duties of the office. She shall be chairman of the program committee.

**Section 9.** The second vice-president shall be chairman of the social service and special funds committee.



**Section 10.** The recording secretary shall keep an accurate record of all proceedings of the club.

**Section 11.** (a) The treasurer shall collect and record all dues and other money paid to this organization. She shall serve with the chairmen of the finance and membership committees in preparing a budget of the expected receipts and expenditures for the year and present same to the executive board. She shall purchase the president's traditional gift.

(b) The books of the treasurer shall be audited by a committee of two members upon the surrender of her office. The committee shall be appointed by the president.

**Section 12.** The corresponding secretary shall have charge of all correspondence of the club and keep a record of same. She shall also serve as chairman of the courtesy and visiting committee.

**Section 13.** The historian shall compile papers and clippings for future reference.

**Section 14.** The parliamentarian shall settle all points of procedure according to Robert's Rules of Order, Revised, which are not inconsistent with the Bylaws.

**Section 15.** There shall be two (2) directors serving as general advisors to the executive board.

## **ARTICLE V**

### **Meetings**

**Section 1.** General meetings shall be held on the first Thursday of each month, from October to May inclusive with the exception of January when there will be no meeting.

**Section 2.** Twenty-five (25) members shall constitute a quorum.



## **ARTICLE VI**

### **Executive Board and Executive Committee**

**Section 1.** The elective officers shall form the executive committee. The executive committee, the immediate past president, two (2) elected directors, and chairmen of all standing committees shall constitute the executive board and shall meet each month prior to the general meeting.

**Section 2.** No member of the executive board, except the incoming president shall serve more than three consecutive years.

**Section 3.** A majority shall constitute a quorum.

## **ARTICLE VII**

### **Standing Committees**

**Section 1.** Standing committees shall be bulletin, courtesy and visiting, decoration, entertainment, extension, finance, hospitality, house, invocation, membership, press and publicity, program, social service, special funds, telephone, and yearbook.

**Section 2.** The bulletin committee shall collect, compile and mail to all members one week before a meeting, a monthly news bulletin.

**Section 3.** The courtesy and visiting committee shall keep in touch with all members and their families in case of illness and bereavement.

**Section 4.** The decoration committee shall have charge of decorations.

**Section 5.** The entertainment/extension chairman and the committee shall be in charge of social functions for the organization and the exchange visits with other Women of Rotary Clubs.

**Section 6.** The finance committee chairman shall have charge of the collection of fees at the general meetings and act as chairman of the finance committee.



**Section 7.** The hospitality committee shall be present to greet members, also obtain new badges and be custodian of the badge boards and arrange for hostesses for the executive board meetings as needed.

**Section 8.** The house committee shall arrange for accommodations for executive board meetings as needed and general meetings, reservations and select the menu for the general meetings.

**Section 9.** The invocation committee shall arrange for a member to give the invocation at each general and board meeting

**Section 10.** The membership committee shall obtain current membership listing from the Rotary Clubs of Ft. Worth and extend invitations to wives of members of the Fort Worth Rotary Clubs to become members of The Women of Rotary of Fort Worth. The membership chairman shall keep a listing of all new members, honorary members and deceased for her current year.

**Section 11.** The program committee shall arrange and recommend all programs for the organization as well as give to the press of the city such information regarding the club and its activities as will be of interest to the public.

**Section 12.** The social service/special funds chair and committee shall have charge of the welfare work of the club.

(a) They shall investigate worthy philanthropic and non-profit projects and attend to the Memorial Fund.

(b) The Chairman shall report special funds recommendations to the executive board at the March meeting for recommendation to the body.

**Section 13.** The telephone committee shall keep members fully advised of meetings of the organization. All cancellations must be made to the chairman.

**Section 14.** The yearbook committee shall arrange and have published the yearbook and have same ready to present to the members at the September meeting.



## ARTICLE VIII

### Parliamentary Authority

**Section 1.** Robert's Rules of Order, Revised shall be used as authority in all cases to which they are applicable and in which they are not inconsistent with the bylaws or standing rules of this club.

## ARTICLE IX

### Amendment

**Section 1.** These bylaws may be amended at any general meeting by a two-thirds vote of those present provided the proposed amendment has been presented in writing at the previous meeting.

## ~~~~~ *Standing Rules*

1. It is the policy of this club to encourage its membership to work and participate in the financing of those worthy institutions of their own choice, but that the funds of this club be used for the operation of the club and for the finance of any project that the club might adopt.

2. The club shall pay for meals of guests appearing on the program.

3. Guests may attend any club meeting.

4. All reservations made and not cancelled with the telephone chairman by Wednesday noon preceding the general meeting must be paid for by the member.

5. Rotarians are welcome at any meeting.

6. No contribution shall be solicited nor project promoted at any meeting of the club unless previously authorized by the executive committee.



## *Standing Rules - Cont'd.*

7. Following the annual election the newly elected president shall be given the courtesy of sitting on the executive board for the remainder of the year.

8. A sum not to exceed twenty-five dollars (\$25.00) shall be allowed by the board to the president, with the consent of the body, for any emergency that may arise.

9. All requests for donations from philanthropic organizations must be submitted in writing to the special funds committee not later than March first of the current club year.

10. A written job description and yearly report from each officer and standing committee chairmen shall be done in duplicate and given to the president by the April board meeting. The president will give one copy to the incoming president and one copy to the other incoming officers and standing committee chairmen, respectively.

11. By vote of the executive board (5/22/86) a medallion with the Rotary crest shall be the gift to our out-going president. This may be changed at any time by the executive board.

12. Binding of the minutes of recording secretary and the yearbooks shall be done every fifteen (15) years.
