Re: Auditor's Report – Review of the FY2016 Equitable Sharing Agreement and Certification forms

The Auditor's Office reviewed the attached *FY2016 Equitable Sharing Agreement and Certification* reports prepared by the Sheriff's Office. The reports are due to the Department of Justice within 60 days of the end of the County's fiscal year. Based on the information recorded in the County's general ledger, the Sheriff's Office records, and the Department of Justice, we believe that the reported amounts of forfeited proceeds received and disbursed by the Sheriff's Office and the ending balances are reasonable as of September 30, 2016.

Through the Federal Equitable Sharing Program, the Department of Justice distributes a share of forfeited property and proceeds to state and local law enforcement agencies that directly participate in an investigation or prosecution resulting in a federal forfeiture. As a participant, the Sheriff's Office must complete and submit the Equitable Sharing Agreement and Certification form within 60 days of the close of each County fiscal year. The form must report the equitably shared funds received during the fiscal year, report how those funds were spent, and report any remaining funds in the agency's account. All Department of Justice and Department of the Treasury funds must be reported on this form.

We appreciate the efforts of the Sheriff Office's staff to facilitate the completion of this review.
