Re: Auditor's Report - Exit Review for the Tax Assessor-Collector

SUMMARY

On December 31, 2018, Ron Wright's term expired as the Tax Assessor-Collector, and his successor, the Honorable Wendy Burgess, assumed office on January 1, 2019. The Auditor's Office conducted selected procedures to provide accountability for the transfer of authority to the incoming Tax Assessor-Collector. These procedures included the verification of cash and other receipts, fiduciary fund balances, and County assets assigned to the Tax Assessor-Collector. *Exhibit A* further describes the scope of our work. Based on the results of our testing, the transfer of authority appears to be complete. The Auditors observed and coordinated minor administrative issues with the Tax Office staff to complete the transition process.

BACKGROUND

The Tax Assessor-Collector assesses and collects taxes on property in Tarrant County and for 63 other taxing units. Also, the Tax Assessor-Collector is responsible for motor vehicle registration and issuing beer, wine, and liquor licenses.

During fiscal year 2018, the Tarrant County Tax Office assessed and collected approximately \$4 billion for property taxes, \$592 million for motor vehicle registrations, and \$793 thousand for beer, wine, and liquor licenses.

Scope and Methodology Tax Assessor-Collector December 31, 2018

- 1) Performed cash counts of change funds in the custody of the Tax Assessor-Collector as of January 2, 2019.
- 2) Determined whether signature stamps and daily deposit slips were used by staff and documented the destruction of these items.
- 3) Verified proper cutoff for manual *receipts*. Reviewed receipts for sequential issuance and unusual items.
- 4) Using the Check Register, verified proper cutoff for computer-generated and manual *disbursements*.
 - Determined whether computer-generated checks and any manual checks issued were issued in sequence.
 - Reviewed the check register for unusual items.
- 5) Verified Tax Office staff requested the bank to remove the *prior* elected official's signature authority and name from all bank reports. We also obtained the new bank signature cards.
- 6) Reviewed the bank account reconciliations for property tax, motor vehicle and vehicle inventory escrow for the months of December 2018 through January 2019, and determined whether they were complete, accurate, and properly approved.
- 7) Obtained documentation to support the removal and addition of authorized signers for the Accounts Payable signature list and ReadSoft authorizations.
- 8) Verified that the *prior* official's security authorizations were <u>deactivated</u> and the *incoming* official's security authorizations were <u>activated</u> for the various County computer systems and applications, as well as the Tax Office online banking.
- 9) Verified the *prior* Tax Assessor-Collector surrendered office keys, building access card, employee identification badge, and other assigned assets.
- 10) Determined whether conference or training fees, dues or memberships were paid from the County's general fund. Obtained reimbursement from the *prior* exiting official as required by policy.
- 11) Determined whether parking facility access was granted and payroll deductions were assessed correctly.
- 12) Determined whether inventory assigned to the office was properly accounted for. Because the reconciliation of inventory by the consultant was not complete, we could not determine whether all assets were properly accounted for.
- 13) Obtained a copy of the incoming Tax Assessor-Collector Official Oath and Bond per Texas Constitution, Article XVI, §1(a) and the Tax Code 6.28.
- 14) Verified the completion of Tax Office deputations.
