Re: Auditor's Report - Review of Financial and System Controls, Justice of the Peace, Precinct 6

In accordance with Local Government Code, the Auditor's Office reviewed financial and system controls in place for the nine-month period ended June 30, 2021. Although we found that financial and system controls were adequate, we observed one issue that requires management's attention.

Specifically, we reviewed 122 cases and observed that the JP inadvertently had not signed 3 judgments. One judgment granting a Drivers Safety Course (DSC) was not signed by the JP. According to the Code of Criminal Procedure Art. 45.0511, the court shall enter a judgment deferring imposition allowing the defendant to complete a DSC. However, the JP signed the final judgment dismissing the charge. The other two final judgments were inadvertently not signed by the judge since he was out of the office. Both judgments were signed during the audit. The JP should implement procedures whereby a periodic review, at least monthly, is performed to ensure that judgments are signed as required by statute. We understand that 100% of the judgments cannot be reviewed.

We also communicated less significant matters to the JP on September 29, 2021. Attached is the JP's management response. We appreciate the cooperation of the JP's staff during our review. Please call me if you have any questions regarding the contents of this report.
