Re: Auditor's Report - Tax Office Ad Valorem Tax Disbursements to Entities

In accordance with Local Government Code, the Auditor's Office reviewed the ad valorem tax disbursements made to taxing entities by the Tax Office for the months of November and December 2021 and January 2022. The objective of our review was to determine whether the Tax Office accurately processed entity disbursements. We tested 100% of the disbursements made to entities for all three months and found that ad valorem tax payments recorded into Tax Client and the Tax Office general ledger were accurately disbursed to the entities. The scope of this review did not include testing to determine whether all monies collected from taxpayers were properly recorded in the Tax Office systems and subsequently deposited.

The entity contracts require renewal for the 2022 tax year. In February 2020, the Tax Assessor-Collector provided a letter to the Auditor's Office stating that the Tax Office would set aside three months of reserve for liabilities related to refunds for overpayments, recalculations, and agreed judgments. In December 2020, the refund liability reserve was changed to six months. The Tax Assessor-Collector and her executive management re-evaluates the amount of the reserve annually based on the prior year actual refunds paid. Since there is no statute that allows the legal authority to retain taxes collected on behalf of the entities for anticipated refunds, the entity contracts should be the governing authority. The current entity contracts do not contain this provision. Prior to renewal of the contract, we recommend that Tax Office staff work with the Criminal District Attorney's Office to amend the contracts to include language that clearly defines how reserves for refunds will be estimated and reconciled each tax year.
