COMMISSIONER'S CORNER

Looking in the Rear View Mirror 2009

I know that most of us are glad to see this year slip into history. There were good times and not-so-good times. In this month's Newsletter, I'll attempt to review **The Good, The Bad, and the Ugly of 2009.**

We'll start with **The Good: January**--The High Honchos at TxDOT invited a small group of us to a special meeting to tell us that the Texas Transportation Commission would very likely approve two major projects in Northeast Tarrant County (that's Precinct 3). Later that month, they approved the North Tarrant Express. This is the North Loop 820 section and Airport Freeway. Local leaders have been working on this project since the early 1980's. This project will start in 2010 and take 4 years to complete.

February--Rebecca Barksdale came on board as our Community Outreach Coordinator. Our Northeast Tarrant Senior Task Force held their first meeting. The Task Force identified three main areas of concern: Senior Health Care, Transportation Options, and Senior Employment.

March--The DFW Connector was approved by the Texas Transportation Commission. This project includes numerous major highways on the north side of DFW International Airport affecting the cities of

Grapevine, Southlake, Colleyville, Coppell, and Irving. Project will start in February 2010 and take 4 years to complete. The Senior Task Force continues to meet.

April--The Senior Task Force decides to have a Senior Expo in the Fall. They start the planning process. I told them that we could enlist sponsors to pay for the Expo and we would find them the money.

May--Mary Ann Rike (the nice lady who keeps EVERYONE in our office in line) organized our "Team Fickes LifeGift Second Chance Run". This run is all about Organ Donation Awareness and is sponsored by LifeGift in Fort Worth. Team Fickes had the largest number of runners with over 160 participating. This year's run is on Saturday, May 15. Call Mary Ann if you would like to join us this year. The Senior Task Force continues to plan for the Senior Expo.

June--We started our "Coffee with the Commissioner" days. We have continued to do this on select Fridays from 7:30-9:00. This is a very causal event at our Hurst office--no structured program, just come by and visit, drink some coffee, have a donut, ask questions and have fun. The Senior Task Force keeps on planning.

July--Commissioner's staff (Carolyn Sims) works with the HEB ISD on a new



Employee Spotlight



Joe Shannon, Jr.



Tarrant County
Criminal District Attorney

District Attorney Joe Shannon Jr. was born in Fort Worth, graduated from Arlington Heights High School and attended the University of Texas. He received his law degree from UT Law School. After graduation Joe was elected to the Texas House of Representatives at the age of 24. He served three terms and chaired the Committee on Counties which dealt with legislation affecting county government. He practiced law with his father until he joined the District Attorney's Office in 1972 when Tim Curry was elected.

Joe became the Chief of the Criminal Division where he prosecuted many high profile cases including capital murders involving robbery homicides as well as the murder of a Fort Worth police officer. The jury returned death penalty verdicts in both

cases. He was also the lead prosecutor in *State of Texas vs. Cullen Davis*.

In 1978, Joe returned to private practice where he remained for twenty-one years. In 1999 he rejoined the District Attorney's Office as Chief of the Economic Crime Unit. He supervised the investigation and prosecution of white collar and computer crime as well as public integrity offenses. The prosecution of major mortgage fraud and identity theft cases was initiated by this unit and is ongoing. He also prosecuted murder cases including the kidnap murder of Lauralee Craine, former director of Starpoint School at TCU. Edward Lee Busby received the death penalty for this offense.

Joe was elected President of both the Tarrant County Bar Association and the Tarrant County Family Law Bar Association. He was also elected Chair of the Board of Directors of the State Bar of Texas, the state agency which supervises the activities of over 83,000 lawyers in Texas. Joe has also managed to find time to serve as an Adjunct Professor at Texas Wesleyan School of Law for the past ten years. He has been listed in Best Lawyers in America and was named as a Super Lawyer by Texas Monthly for his prosecution skills.

In May 2009 when then District Attorney

Tim Curry passed away Joe Shannon was selected by Governor Rick Perry to serve as Tarrant County's Criminal District Attorney for the remainder of the term. He brings energy, experience and enthusiasm to the job of chief prosecutor of Tarrant County.

Joe has three children and is the proud grandfather of six grandchildren one of whom has been accepted into law school.

We have certainly had some beautiful weather this winter, but then Mother Nature decided to throw in the snow and ice for Christmas. It was the first white Christmas for as far back as most could remember, and it was beautiful. With the beauty came some challenges for the drivers on the road. Our team was prepared and they were out on Christmas Eve and Christmas Day improving the driving conditions at busy intersections as much as possible. We used sand, salt, and Ice Melt on the roads and in one area had to remove a snow drift that was too deep to drive through.

We have completed Phase I of the Westport project for the City of Haslet and have started Phase II. Portions of Old Denton Road in Fort Worth have been reconstructed as well as a parking lot for the JPS facility on Brown Trail. The parking lot surface is much smoother for those who park there, and we improved the drainage

issues as well.

We continue to crack seal some of our roads to prevent water from seeping under the pavement and causing potholes. Our storm water ditch cleaning is underway, and we have been clearing some brush from intersections to help with sight distances for the safety of the traveling public.

With warm weather approaching, our project list for road maintenance and construction will expand. We anticipate a busy and productive spring and summer working with the cities in Precinct Three to improve the condition of our roadways.

While traveling in our construction areas please be aware of our construction workers and equipment, and take extra precautions in order to prevent accidents or injuries.

Over the past thirty years, MMOW has been an ever-present resource of volunteers visiting seniors who are striving to live independently in their own homes, leaving behind hot meals, hugs, and smiles. MMOW has provided assurances for the seniors—freedom from worry about food, knowledge that there will be a personal visit every day, and for their families—that someone who cares will look in on their loved one daily.

MMOW's outreach is not limited to

homebound seniors; our luncheons are special events for seniors in eight communities. Depending on site, attendance ranges from 35 to 125+ seniors per luncheon. Fabulous food, lively conversation, dominoes, cards, bingo, and birthday celebrations make MMOW's luncheons a "not-to-be-missed" occasion regardless of whether the participants are lifelong residents or new to the community.

where no other services were available. For thirty years, MMOW has been dedicated to providing support for seniors in Northeast Tarrant County. What began as concerned volunteers cooking and delivering a weekly meal to elderly or sick neighbors has grown into a strong grassroots organization that provided 62,340 meals to 935 participants in twenty-two communities in three counties last year. MMOW has been joined by food partners in each of our communities and by over 500 volunteers, 185 of whom have volunteered for between five and thirty years!

School Based JPS Clinic. Senior Task Force brands Senior Expo as "Empowering Seniors '09" and we find the sponsors to help pay for this event. The plan is to serve a light breakfast and a sit down lunch for 250 seniors, provide morning seminars (6), have 25-30 exhibitors, and a keynote speaker at lunch and not charge anyone for anything. Sounds easy!

August--Back to School Roundup in Fort Worth and the HEB ISD. We had all hands on deck for this project. Our Team worked with volunteers across the County to help over 10,000 students get a great start on the school year. The Senior Task Force gets very busy planning "Empowering Seniors '09". Event will be at Richland Hills Church of Christ on October 29.

September--Commissioners Court gets serious about the 2009-2010 Budget. It's cutback time; spend less and do more. We approved a Budget that was \$9,000,000 less than last year. The Senior Task Force is really in gear for "Empowering Seniors '09".

October--This was a really busy month! We started off by having our United Way Fund Raiser with a Burrito/Chick-fil-A Chicken Biscuit Breakfast and a Catfish Lunch. It rained most of the morning, but we still sold lots of food and everyone had a great time. We raised over \$1,500 for

United Way. We started planning for the Northeast Tarrant County Transportation Summit to be held in Grapevine on February 17, 2010. We put together a great committee of local transportation leaders to work on this project. On the 29th we had our "Empowering Seniors '09 Conference". We had about 250 seniors attend. All the seminars were well attended, health testing was performed by four local hospitals, and we had a fabulous lunch with a great speaker...and it was all provided free to our Great Seniors.

November--We had our Tarrant Area Food Bank Drive and raised enough money from Tarrant County employees to purchase 5,000 turkeys for distribution at Thanksgiving. The Commissioners Court members had the honor of helping unload those 5,000 icy, cold, hard, frozen turkeys.

December--The second JPS HEB ISD School Based Clinic opened. A special thanks to Theresa Parsons in our Southlake office for all the great work she does on putting together our Newsletter every other month.

The Bad: January and March--Those two great Highway projects mentioned above mean that we'll be under construction for the next four years on the north and south areas of Precinct 3. No pain, no gain!

May--Long time Tarrant County Crimi-

nal District Attorney, Tim Curry, passed away. The very capable Joe Shannon was appointed by Governor Rick Perry to complete Tim's term.

August--Swine Flu becomes the number one news item for months. The ailment's name, "Swine Flu", so upset the Hog Raisers that the CDC decided to re-name the ailment something that made more sense: "H1N1"! Tarrant County Public Health did a fabulous job in handling this problem. They opened special clinics at six locations and held numerous vaccination events at large venues in all parts of Tarrant County. We are all very proud of the great effort put forth by all of their employees to reduce the danger for citizens of Tarrant County.

The Ugly: July and November--Myself and one Key Associate turned 60 years old during 2009. This year ended.

Besides all of that mentioned above, we also worked with the cities in Precinct 3 on road and bridge projects; sanded the roads and bridges on Christmas Eve and Christmas morning during the ice/snow storm; worked every day with constituents' problems and questions. We are here to serve you and your needs concerning County government.

Neighborhood Revitalization Program

At a recent luncheon hosted by Commissioner Fickes, Mayor McGrail of Keller, Mayor Trevino of North Richland Hills, Mayor Ragan of Richland Hills, and Mayor Harry Jeffries of Watauga, representatives from the churches, area businesses, and volunteers learned of a revitalization program that the City of Euless and 6 Stones Mission Network have implemented. Here is their story...

Mission Euless Revitalization

In the fall of 2007, two local churches approached the Euless City Manager with a question: "What can we do to help?" Rather than a mission trip abroad, they were brainstorming ways to



make a difference in our own backyard. They found an answer: In late June, in an unprecedented effort of teamwork and volunteerism, nearly 500 volunteers helped revitalize 15 Euless homes over two days through the Euless Revitalization program.

Since then the ER committee has evolved and grown into a coalition of churches, local businesses, civic groups and individuals, all working with Tarrant County and the City of Euless to help return hope to families in need. Euless Revitalization has not only built a better community, it has built better relationships within our community.

In the same way that decline can begin to infect a community, so can pride of ownership inspire a community. The program has had an incredible trickledown effect in the neighborhoods where homes were revitalized through the program. When neighbors noticed how nice the revitalized homes looked, they began cleaning up their yards and sprucing up their homes. Participants in the program were overwhelmed by the daunting size of the repairs needed on their homes. They now have hope once again and pride in their homes.

The City of Euless is fortunate to tap

into some of the most dedicated and hard working volunteers in Texas and the contribution they make is FabEuless! Volunteers of all ages, skill levels and knowledge were able to lend their neighbors a helping hand and this program will only continue to grow. We're changing lives one house at a time.

This joint effort by District Clerk Tom Wilder and County Commissioner Gary Fickes provides the opportunity for members of the public to view and obtain records from Civil, Family and Criminal (Felony) cases in one of Tarrant County's Sub-Courthouse locations. Self-service research will be free to the public, with basic records search performed by a deputy priced at only \$5.00, and nominal charge for copies, if desired. The public access terminal will be located in the District Clerk's Passport Section, located in suite #340 of Southlake Town Hall, 1400 Main Street, Southlake. An Historical Moment In Time

An important "Historical Moment in Time" occurred in Tarrant County 151 years ago – and it remains important to us today! That moment in time was in 1859 when Thomas Jefferson Nash and his wife, Elizabeth, bought farmland and a log cabin in Grapevine and created Nash Farm. In 1869, after the Civil War, they built a new farmhouse and, later, a big barn that is standing proudly today. Nash Farm is now owned by the Grapevine Heritage Foundation and is a living history farmstead. It has been restored to

perfection and will soon be listed on the National Register of Historic Places.

If you are looking for an



outing for your family that is fun, economical, educational and close to home, look no farther than Nash Farm! The Farm offers a great schedule of diverse monthly activities geared for the entire family. Activities are offered either free of charge or for a nominal fee. At Nash Farm you will find farm animals, vintage farm equipment, a large kitchen garden, crops growing in the field, the barn, and a colorful farmhouse to explore. Friendly, knowledgeable docents are always willing to share a story, guide educational activities, and explain what farm

life was like in the mid- to late 1800s.

Answer to Question of the Month

Question: How did Fort Worth acquire the nickname "Panther City"?

Answer: Fort Worth city leaders had worked for many years to extend the railroad from Dallas west to Fort Worth. When a national depression in 1873 halted rail construction, so many people left town that it was said that a panther could sleep unmolested on Main Street. In 1876, the Texas & Pacific arrived and Fort Worth boomed.

P.S. Visit the front lawn of the County Administration Building located at 100 E. Weatherford and see the large bronze sculpture of the "Sleeping Panther".

The Commissioners Court of Tarrant County congratulates the Southlake Department of Public Safety, the Southlake City Council, and the Southlake Crime Control and Prevention Board on their foresight in establishing this campus to continue the vision of providing effective and efficient professional police and fire services to the citizens of Southlake, Texas. The grand opening of the City of Southlake DPS Headquarters took place on Friday, January 8, 2010 following nearly two years of construction. Located in the northwest corner of the Southlake's Town Square, this new state of the art, 85,000+ square foot building, houses the DPS, Police and Fire Administration, the City's Municipal Court and Metroport Teen Court.
