PROGRAM STATUS

- The **Small Business Assistance** is in the reviewing and processing stage. Auditor's Office staff will distribute the second round of funds Tuesday, August 4th.
- The **Rental Assistance Program** is ongoing with a rolling approval process. New applications are submitted daily.
- The **NGO Assistance Program** received 148 applications. Initial application review through Aug 7. Applicants who did not submit all required information will be contacted and given the opportunity to send necessary documents.
- **Municipal Distributions** are complete with all cities receiving CRF Funds. County staff is currently waiting on the submittal of city budgets.
- **Chamber Partnerships** – 10 chambers have entered into agreements with Tarrant County.

COVID-19 Related Economic Loss

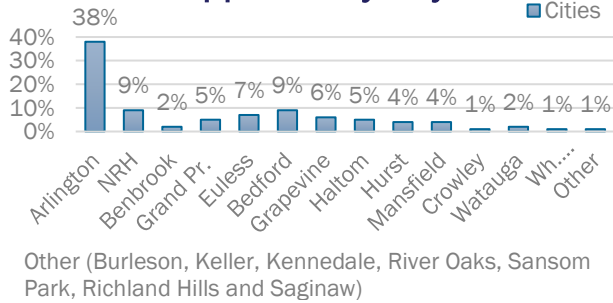

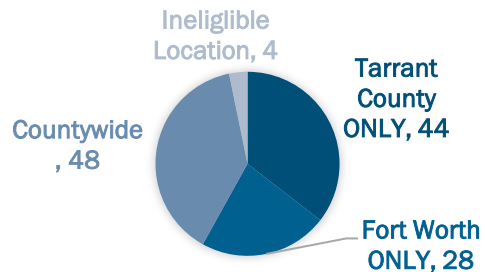
