PROGRAM STATUS

The second round of the **Small Business Assistance Program** review is in process. The review and awarding of grants has begun. The round 2 application portal closed November 10th at 6:00pm.

The County operates **6 COVID-19 Testing Sites** in partnerships with the City of Arlington, City of North Richland Hills, City of Fort Worth, City of Azle and Arlington Independent School District.

The **Rental Assistance Program** is ongoing with a rolling approval process. New applications are submitted daily.

As of November, 23rd, the **NGO Assistance Program** has approved 81 awards equaling about \$8.2 million in Tarrant County CRF Funds.

Municipal Distributions are complete with 39 cities receiving CRF Funds. County staff is working with cities during weekly office hours.

Chamber Partnerships – 10 chambers have entered into promotional service agreements with Tarrant County.

SMALL BUSINESS ASSISTANCE

The County will approve 157 grants the week of November 24th totaling \$1,262,963.36. The cumulative total is 2,524 awards equaling \$20,239,595.80.

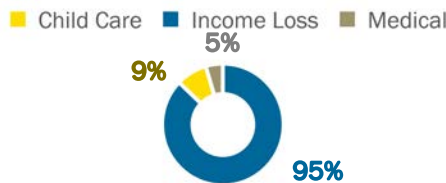

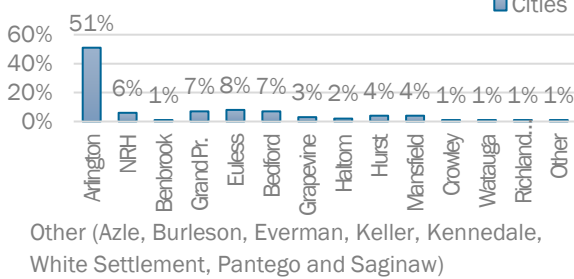

- For capital expenses, assets must be **in use** by December 30
- Municipalities are required to review all capital expenditures and documentation to ensure compliance with current guidance; the County is developing a checklist with guidelines to support reviews
- The County is also developing a close out process for municipalities that have fully expended their CRF funds
