We are prepared to do another e-filing seminar in our office if there is enough interest. Please e-mail mmfoster2@tarrantcounty.com if you would like us to put on a program. In fact, I am sending a manager to the TCBA CLE course on July 21, 2022, to discuss e-filing and other things.

I certainly hope things are getting back to normal on your end because they are in the District Clerk Office. We have ramped up our efforts, along with the County Clerk, to assist in getting the new TechShare Court Software produced, tested, and implemented in the Criminal Section. Family and Civil will come right after the criminal piece is finished and de-bugged.

On another issue, we are 93% complete on scanning old paper records that date back to 1873. These will be available on your subscriber access (DCSA) after indexing and quality control are complete. Of course more records, from today going back several decades, are on DCSA now. This was a huge undertaking that was largely funded by a special court fee that paid for the project staff to do the job.

Is your contact information up to date?

It is important to remember to keep the District Clerk's office notified of your current mailing address as well as firm name, phone/fax #'s and most importantly email addresses as required by TRCP Rule 21(f)(2). The District Clerk's office maintains an attorney database that has this information for each attorney that e-files pleadings with the District Clerk's office. This is information we use when emailing out letters or Orders signed by the Judges. We want to ensure you receive the information we email out in a timely manner.

There have been several requests made by attorneys to add additional email addresses along with the one we have for the attorney. We have limited space in the email address field and often find there is not enough space for 2 email addresses. You might want to consider getting a global email address for your office that everyone has access to. Please remember to add the District Clerk's office to your check list if you move to keep us apprised of any new information.

District Clerk Unfiled Criminal Documents

As of January 1, 2021, the District Clerk records section has access to unfiled court documents for magistrated defendants in Tarrant County. The following documents can be obtained before the criminal case is filed and may consist of the following:

- a. Probable Cause Affidavit;
- b. Probable Cause Determination;
- c. Arrest Warrant;
- d. Arrest Warrant Affidavit;
- e. Magistrate Warning;
- f. Conditions of Bail
- g. Personal Bond;
- h. Order of Emergency Protection;
- i. Firearm Warning;
- j. Article 16.22 Mental Health Order;
- k. Article 16.22 Written Report, to be filed under seal; and
- I. Any other record designated by a magistrate



To obtain any documents for magistrated defendants whose cases have <u>NOT</u> been filed by the District Attorneys Office yet, please email:

To obtain a non-certified copy of an executed Search or Probable Cause Warrant please visit our public search and probable cause site.
