

DISTRICT CLERK CORNER

Dear Legal Professionals:

A new day is dawning for us all. Tarrant County has completed their new backup system for access to electronically stored records.

Accordingly, we will be accelerating our destruction schedule for older court records, there are 600 boxes with over 50,000 court case files that we show in the picture herein that will be shredded. All cases have been verified to have good images and are properly loaded in our case management system.

Some years ago, I implemented a "famous case" identification process using professional archivists from the Star-Telegram, Historical Society, noted local author Richard Selcer of "Hells Half Acre" fame and my staff. The Committee identified famous cases like the Melvin Belli and Lee Harvey Oswald Civil cases and the many famous murder cases that have been featured on TV programs. **These records will not be destroyed even though they have been imaged.** We have a special secure room for them in house with monitored and controlled access.

The benefit, of course, is to save warehouse space and tax payer dollars by storing the records electronically rather than in paper and be able to access our court records in case of a disaster.

Also, a new criminal evidence room is near completion that will more securely store our evidence and use less space than what we use now because of a better design.

Finally, **effective February 1, 2019, we will go paperless and no longer print out paper files at all.** Now that we have a modern backup system in place and fully tested, it is the next step which is authorized by the Supreme Court and statutes for District Clerks to implement.

DISTRICT CLERK TOM WILDER IS PREPARING TO SHRED PAPER COURT RECORDS NOW. 600+ BOXES AND 50,000+ FILES FOR STARTERS.

Tarrant County completed its new records back-up system in July and we tested the fail-over function that allows the hot site to pop up and the redundant back-up in The Cloud.

This will save tax payer dollars we have to spend on warehouse space and provide better capability to restore access to court records in the event of a disaster.



Service Request Form

When requesting citations please fill out your service request form or your correspondence with same party information as original petition. If the original petition states on defendant party info by serving registered agents, or manager, etc. you will need to put this on the service request form or your correspondence. If you leave off this information, then we will have to take off the by serving info and only leave the address. When e-filing, please be sure to e-file the service request form as a lead document.



File a Case in Civil vs. Tax

If you are filing a case against the Tarrant Appraisal District please be sure you are filing into the correct case category. Civil - Tax is only for cases regarding delinquent taxes and should not be chosen when filing against the Tarrant Appraisal District. 

Attorneys, upon getting a protective order signed please make sure that you have completed all required documents and that you bring the signed order *directly* to the Family section of the District Clerk's office. We are experiencing delays in getting Protective Orders processed, due to the signed order being left in court or the required documents are not completed/filed.

Criminal e-File

For its inaugural debut, the District Clerk’s Criminal e-File Department has made important strides in complying with the State’s e-File Mandate. Prior to the official mandate, within our testing phase, Criminal e-File had a Return Rate of nearly 25%.

By the end of FY2018, that rate dropped to 10.17%, with the final Quarter Average just under 8%! This improvement would not be possible without the cooperation & assistance of the legal community filing into the criminal district courts. As shown below, Criminal e-File has reviewed over 41,000 documents & returned nearly 4,200 for correction.

- Always include an Attorney Email & Signature somewhere on the physical document
- Proposed/Unsigned Orders must be included with their motions as one lead document
- Proofread your documents prior to submission for common errors like wrong cause number, court, defendant, jurisdiction, or some other missing detail.

Criminal Case Filings

Criminal case filings for FY2018 were 20,973; an increase of 16% over FY2017's filings of 18,119. This is a record case filing year for the District Clerk's Criminal Section.

The District Clerk's Felony/Civil section also saw an increase in filings this year. There were 3,007 cases filed; an 11% increase over FY2017's 2,711 filings. This was also a record number of filings.
