## \$10 ADMN FEES CHARGED – REGISTRATION/LICENSE PLATE OFFENSES:

<b>Fail to Display Registration Insignia on vehicle</b>	<b>1. Proof that vehicle was registered for the period; and 2. Registration was attached to vehicle before D's first court appearance</b>	<b>\$10.00 admn fee</b>
<b>Attaching or Displaying a Numbered Plate or Registration Insignia assigned for a period other than period in effect</b>	<b>Defect remedied before D's first court appearance</b>	<b>\$10.00 admn fee</b>
<b>Number Plate or Registration Insignia has letters, numbers, or other identification marks not visible at all times in daylight</b>	<b>Defect remedied before D's first court appearance</b>	<b>\$10.00 admn fee</b>
<b>Number plate or registration insignia has attached illuminated device, sticker, decal, emblem, or other not authorized by law that interferes with readability</b>	<b>Defect remedied before D's first court appearance</b>	<b>\$10.00 admn fee</b>
<b>Number plate or registration insignia has coating, covering, or protective material that distorts, alters, obscures the numbers, color, or original design features of the plate</b>	<b>Defect remedied before D's first court appearance</b>	<b>\$10.00 admn fee</b>

**\$20 ADMN FEES CHARGED – REGISTRATION/LICENSE PLATE OFFENSES:**

Driving with expired MV registration	1. D remedies defect not later than the 20th working day after date of offense; OR 2. Before D's first court appearance date, whichever is later; AND 3. D establishes that delinquent registration fee prescribed by TC502.176 paid	\$20.00 admn fee

**\$20 ADMN FEES CHARGED – MOTOR VEHICLE INSPECTION OFFENSES:**

Driving with expired inspection certificate	1. D remedies defect within 20 working days OR 2. before D's first court appearance date, whichever is later; AND 3. inspection certificate has not been expired for more than 60 days	\$20.00 admn fee

**\$10 ADMN FEES CHARGED – OPERATING VEHICLE OFFENSES:**

Operating a vehicle that is not properly equipped (does not apply to commercial vehicles)	D remedies defect before first court appearance	\$10.00 admn fee
Operating a vessel with expired certificate of number (P&W)	1. D remedies defect not later than the 10 <sup>th</sup> working day from offense date AND 2. Certificate of number has not been expired more than 60 days	\$10.00 admn fee

**\$10 ADMN FEES CHARGED – DRIVER’S LICENSE OFFENSES:**

<p><b>Imposition of Special Restrictions or Endorsements</b></p>	<p>1. Restriction or endorsement was imposed; (a) because of physical condition that was surgically or medically corrected before date of offense;                  OR (b) in error and fact is established by the D                   2.DPS removes the restriction or endorsement before D’s first court appearance</p>	<p><b>\$10.00 admn fee</b></p>
