This total includes the taxable value of homesteads with tax ceilings (will deduct in Line 2).</p> | \$ <u>12,486,792,335</u> |
| 2 | <p>2017 tax ceilings and Chapter 313 limitations.</p> <p>A. Enter 2017 total taxable value of homesteads with tax ceilings. These include the homesteads of homeowners age 65 or older or disabled.¹</p> <p style="text-align: right;">\$ <u>1,381,477,793</u></p> <p>B. Enter 2017 total taxable value of applicable Chapter 313 limitations when calculating effective maintenance and operations (M&O) taxes. Enter zero when calculating effective debt service taxes. | 5 | <p>2017 taxable value lost because court appeals of ARB decisions reduced 2017 appraised value.</p> <p>A. Original 2017 ARB values: \$ <u>0</u></p> <p>B. 2017 values resulting from final court decisions: - \$ <u>0</u></p> <p>C. 2017 value loss. Subtract B from A.</p> | \$ <u>0</u> |
| 6 | 2017 taxable value, adjusted for court-ordered reductions. Add Line 3 and Line 5C. | \$ <u>11,105,314,542</u> |
| 7 | 2017 taxable value of property in territory the school deannexed after Jan. 1, 2017. Enter the 2017 value of property in deannexed territory. | \$ <u>0</u> |
| 8 | <p>2017 taxable value lost because property first qualified for an exemption in 2018. Note that lowering the amount or percentage of an existing exemption does not create a new exemption or reduce taxable value. If the school district increased an original exemption, use the difference between the original exempted amount and the increased exempted amount. Do not include value lost due to freeport or goods-in-transit exemptions.</p> <p>A. Absolute exemptions. Use 2017 market value: \$ <u>915,891</u></p> <p>B. | 10 | Total adjustments for lost value. Add Lines 7, 8C and 9C. | \$ <u>35,834,611</u> |
| 11 | 2017 adjusted taxable value. Subtract Line 10 from Line 6. | \$ <u>11,069,479,931</u> |
| 12 | Adjusted 2017 taxes. Multiply Line 4 by Line 11 and divide by \$100. | \$ <u>139,807,531</u> |
| 13 | Taxes refunded for years preceding tax year 2017. Enter the amount of taxes refunded by the district for tax years preceding tax year 2017. Types of refunds include court decisions, corrections and payment errors. Do not include refunds for tax year 2017. This line applies only to tax years preceding tax year 2017. | \$ <u>0</u> |
| 14 | Adjusted 2017 taxes with refunds. Add Lines 12 and 13. | \$ <u>139,807,531</u> |
| 15 | <p>Total 2018 taxable value on the 2018 certified appraisal roll today. This value includes only certified values and includes the total taxable value of homesteads with tax ceilings (will deduct in Line 17). The list shows the appraisal district's value and the taxpayer's claimed value, if any, or an estimate of the value if the taxpayer wins. For each of the properties under protest, use the lowest of these values. Enter the total value. \$ <u>320,602,777</u></p> <p>B. 2018 value of properties not under protest or included on certified appraisal roll: The chief appraiser gives school districts a list of those taxable properties that the chief appraiser knows about, but are not included in the appraisal roll certification. These properties are not on the list of properties that are still under protest. On this list of properties, the chief appraiser includes the market value, appraised value and exemptions for the preceding year and a reasonable estimate of the market value, appraised value and exemptions for the current year.
